Executive Summary

- This report details all activities undertaken by Keep Wales Tidy's environmental officer in the first year of implementation of the Sandfields East and Aberavon Renewal Area project.
- The officer is working with the community to tackle the problem of adverse environmental quality by implementing all KWT's programmes and projects including; Clean Rivers, Clean Coasts, LEAMS, Flytipping, Eco-schools and awareness-raising campaigns.
- A LEAMS survey was initially conducted in October 2005 and identified areas that needed attention. These have been tackled and when the survey was repeated in November 2006, it showed an improvement in **25 streets**. The survey also highlighted an improvement in the incidences of dog fouling which can be directly attributed to the awareness campaigns that the officer has run this year.
- The officer has spent much time forging links with the local authority and organisations that operate within the Renewal Area and has been out meeting the community at various events. **11 events** have been attended this year.
- The officer sits on **9 partnership** sub-groups to ensure she understands the needs of the community and is aware of all issues.
- 1 volunteer group (Daclus Sandfields Aberavon) has been established to tackle environmental issues. They have a core of **13 volunteers** who meet monthly to plan events. The group is involved with all the officers environmental activities.
- **6 community talks** have been given by the officer to raise awareness.
- Dog fouling has been highlighted as an issue of concern and so **6** small-scale dog fouling campaigns have been run.
- **10 community skip events** have been held resulting in the collection of 10 tonnes of bulky waste which could have otherwise been flytipped.
- A large-scale awareness raising event was held in the Renewal area as part of Tidy Wales Week 2006. Edwina Hart visited 5 different activities that took place.
- Both schools in the RA are signed up to Eco-schools programme and the officer is assisting them to move up through the award levels. 3 schools just outside the area have also been signed up.
- A successful partnership between KWT, Young Offenders and Daclus Sandfields Aberavon has been established to tackle Graffiti removal.
- The project has been featured **25 times** in the local press.

1. Introduction

The project's main aim is to involve communities in the care of their local environment and to work more closely with the Local Authority to reduce the problem of littering, fly tipping, dog fouling and other environmental issues to create a sustainable solution for the future of the recently established Renewal Area of Aberavon and Sandfields East.

This pilot project involves Keep Wales Tidy working with the community to tackle the problem of adverse local environmental quality by implementing all of its programmes and projects in a concentrated area. Keep Wales Tidy will use the successful methods and experience gained from its Rivers, Coast and Flytipping projects as it attempts to engage local communities. It also includes People and Places implementation by the Local Authority, practical delivery of Eco-schools and piloting of awareness-raising campaigns.

1.1 Objectives

- To work with the community to assess the condition of the local environment, identify local issues of importance and areas for improvement.
- To identify what local people see as the priorities for action.
- To establish, support, train and promote community group action that focuses on practical environmental works (clearance, prevention and improvement).
- To implement the People and Places Program in the area.
- To raise awareness of the problems and solutions to local issues of importance.

2. Mechanisms for Completion of Work

2.1 Local Environmental Audit Management System

A baseline for cleanliness of the Renewal area needed to be established to enable effective monitoring and evaluation of the work of the officer. To this end the Officer underwent Local Environmental Audit Management System¹ (LEAMS) Training by KWT staff in order to undertake a LEAMS Survey of the Renewal Area.

The first survey was undertaken in November 2005 and gave a cleanliness index of 63 for the seventy-four streets within the Renewal Area boundary which is below average. *Nb the benchmark figure is 66.7 (this equates to all streets being grade B).*

The survey highlighted areas that required remedial action:

- Litter pick in Darwin Road – *undertaken in March 2006.*
- Clean-Up campaigns around the White City area of Aberavon – *undertaken in June 2006.*
- Raising Awareness of Dog Fouling issues around Old Aberavon - *ongoing*

¹ LEAMS is a method of measuring the cleanliness of an area using the standards identified in the Code of Practice for Litter and Refuse (1999). The LEAMS survey system looks at Adverse Environmental Quality Indicators (AEQI's) which affect the public's perception of the local environment, such as vandalism, graffiti, dog fouling, flyposting and weed growth.

- Tackle Graffiti across the Renewal Area - *ongoing*.
- Identifying green spaces for landscaping initiatives - *ongoing*.
- Improve streets adjacent to the industrial site at Green Park – *planned for 2007*.

The survey has become a tool for monitoring and assessing improvements. The second LEAMS survey was undertaken in November 2006 and comparative figures show an improvement of the cleanliness of the area following a year of activities by the Project Officer. The cleanliness index for 2006 was 67 which shows an improvement on 2005 results and takes the area to above average.

2006 Survey

- *Four Streets achieved an 'A' Grade compared to only 1 in 2005.*
- *Twenty-two Streets achieved a 'B+' Grade compared to only twelve in 2005.*
- *Thirty-three Streets achieved a 'B' Grade compared to twenty-four in 2005.*
- *Thirteen Streets achieved a 'C' Grade in both 2005 and 2006. 'C'*
- *Only One Street achieved a 'D' Grade compared to five in 2005.*

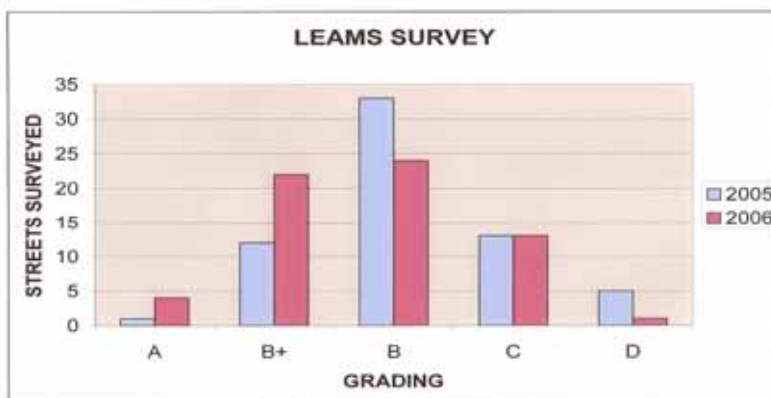
Twenty-five Streets showed an improvement, whilst only three showed any deterioration. The streets which remained the same were predominantly from Sandfields East; streets from the older areas of housing stock like White City and Old Aberavon showed an upturn in street cleanliness; so much so that the residents of Borough Street have expressed interest in becoming involved in a graffiti removal project to eliminate the remaining graffiti on the warehouses.

Dog Fouling:

In 2005 dog fouling was found on 21 streets within the Renewal Area; this dropped to only 13 streets in 2006 and can be directly attributed to the dog fouling campaigns that have been run through the year. The faeces was graded between 1 to 4 (depending on the amount present) and totalled 31 in 2005; this reduced to only 15 in 2006.

Recommendations from the 2006 Survey include a programme of litter picks for 2007, continuation of the awareness-raising campaigns and supporting the Schools, residents and voluntary groups to improve their community.

2.2 Environmental Strategy

To guide the Renewal Area Team through its ten-year plan, an Environmental Strategy was commissioned. This document will become the influence and guide for all the environmental projects over the forthcoming years. The Project Officer will be working closely with the Renewal Team to ensure that the environmental enhancements highlighted in the strategy are implemented and sustainable improvements to the physical environment of Sandfields East & Aberavon Renewal Area are achieved.

2.3 Partnership with the Local Authority

The Local Authority has a dedicated team of staff to steer the Renewal Area through its ten-year programme, with posts including Support Officers, Environmental Health Officers, Surveyors and Housing Renewal Officers.

The Keep Wales Tidy officer is based in the Renewal Area office and so benefits from daily contact with the Team, which has been extremely beneficial in terms of information exchange, project planning, sharing office resources, attending events and awareness raising campaigns.

2.4 Forging Links with the community

Throughout the past year, the Project Officer has met with many environmental groups and initiatives that already operate within the Renewal Area. The Officer has also attended many community events, festivals and consultations to raise awareness of the project and to meet members of the public:

2.6 Establishment of Volunteer Groups

To date, one Keep Wales Tidy voluntary group has been established. Daclus Sandfields Aberavon (DSA) became constituted in April 2006 and have been busy raising funds to carry out greening initiatives within the Renewal Area. Since April 2006, DSA have received £3,130 in grants and have a further £10,500 pending.

The group has a core membership of thirteen volunteers who meet monthly. At these meetings they identify and nominate environmental issues within the Renewal Area. They then work with the project officer to plan their activities and publicise their upcoming events. The group are a great support to the Project Officer, making themselves available to assist at practical hands-on events including clean ups, awareness raising events and campaigns and other initiatives arranged within the Renewal Area.

2.7 Clean-Ups

Clean Ups are not only needed to increase the aesthetic value of the area but they also increase the profile of Keep Wales Tidy and the Renewal Team in the area and hopefully encourage the local residents to take some pride in their community.

Case study

The first cleanup was held on 21st March 2006. To ensure the event was a success, a number of areas were tackled at the same time;

- Consultation for improvements to the surrounding area.
- Litter pick on the footpath alongside the River Afan by 65 local school children and 15 Sea Cadets.
- Community skip event, where residents were invited to utilise the skip and remove waste from their houses and gardens.
- River clean – where volunteers removed litter and debris from the river and river banks.

In total over **2 tonnes of waste** was removed over a two day period. 107 volunteers were involved dedicating 175 volunteer hours and £156.03 of benefits in kind donated from various local businesses.

2.8 Community Talks & Events

2.9 Raising Awareness:

Campaigns to raise awareness are regularly undertaken. They are generally organised to highlight points of concern from previous consultations. Dog fouling is a major issue of residents in Aberavon and so has been the first campaign tackled as part of the project.

2.9.1 Dog Fouling Campaign

DOG FOULING AWARENESS

Dog Fouling is unpleasant and dangerous. It carries bacteria that can harm you and your family!

With your help we can encourage all dog owners to be responsible and eradicate dog fouling on our streets.

During this period, **6** dog fouling campaigns have been run, targeted at pet owners.

These have consisted of distributing dog bags and leaflets to the general public.

The campaigns have been multi-partnership events between Keep Wales Tidy, Neath Port Talbot CBC Enforcement Team and members of the Renewal Team all of whom are highlighting the health and legal implications of dog fouling. As a direct result of the dog fouling campaigns NPT Enforcement Officers have issued fixed penalties of £75 to offenders.

2.10 Community Skips

The community skip events are probably the most successful clean-up campaign of all. Skips are sited in strategic areas (based on the areas highlighted during the LEAMS Survey) across the Renewal Area and residents are invited to dispose of unwanted items.

These events are also used to educate the residents on the legal aspects of fly tipping and alternative services that could be utilised, such as the Local Authorities Bulky Waste Collection Scheme.

To date over 10 tonnes of rubbish has been removed through ten community skip events. The cost of the skips is estimated at £900, which have been generously provided by the Renewal Area, NPTCBC, Workways and Daclus Sandfields Aberavon.

3. Tidy Wales Week - Renewal Area Event

As part of Tidy Wales Week 2006, a high profile event was organised for the Renewal area. The event consisted of a multi-partnership blitz of the area to tackle a range of local environmental quality issues. 5 different activities were held consecutively to coincide with a visit from Mrs Edwina Hart AM, the Minister for Social Justice and Regeneration.

- *Community Skip at Henshaw Street.*
- *Graffiti removal at Borough Street.*
- *Litter picks around the area.*
- *Clean up at Sandfields Primary Nature Reserve.*
- *Raising Awareness Event inside St Paul's Church Hall.*

In total 1.5 tonnes of rubbish was removed during the day. Following the event, an ongoing programme has now been arranged to help Sandfields Primary School improve their Nature Reserve after vandalism left it unfit for use by the schoolchildren.

4. Eco-Schools:

The Eco schools programme is an International programme designed to encourage schools to take action for the environment. Although there are only two schools within the Renewal Area boundary, both are actively working on the programme.

- **Sandfields Primary School** – Green flag status was awarded on 21st May 2004. We are working closely with the school to maintain this award by renovating their Nature Reserve. The Project Officer regularly attends the school for talks, competitions and events.
- **St Josephs Infants School** – Bronze status awarded on 1st April 2003, the Project Officer is helping Communities First by raising grants to install an outside classroom and garden. The Officer regularly attends the school for talks, competitions and events and is assisting them to move up to the silver award.

Although they are located just outside of the Renewal Area boundary, Tir Morfa and Rhosafan Primary Schools and St Josephs Comprehensive School have all been signed up to the Eco-Schools programme by the Project Officer.

5. Graffiti Removal:

Graffiti within the Renewal Area is also a major problem and a multi-agency partnership approach has been adopted to tackle this particular issue. Before the KWT officer was employed, graffiti was removed by various organisations under differing circumstances:

- Neath Port Talbot Community Safety Team will remove graffiti on the property of the elderly, disabled or a minority group.
- 'Service First' will remove blasphemous, vindictive or race related graffiti from community buildings and local authority properties.

This left many incidences of graffiti that no authority had responsibility for. In an effort to resolve this problem Keep Wales Tidy and the Youth Offending Team (YOT) entered into a Service Level Agreement in an effort to resolve the problem.

The voluntary group, DSA, successfully applied for a Communities First Trust Fund Grant in order to purchase specialist equipment for the removal of graffiti. In return the YOT have agreed to undertake a minimum of 12 hours graffiti removal per month within the Renewal Area; the equipment is then available for use within the Borough by the YOT.

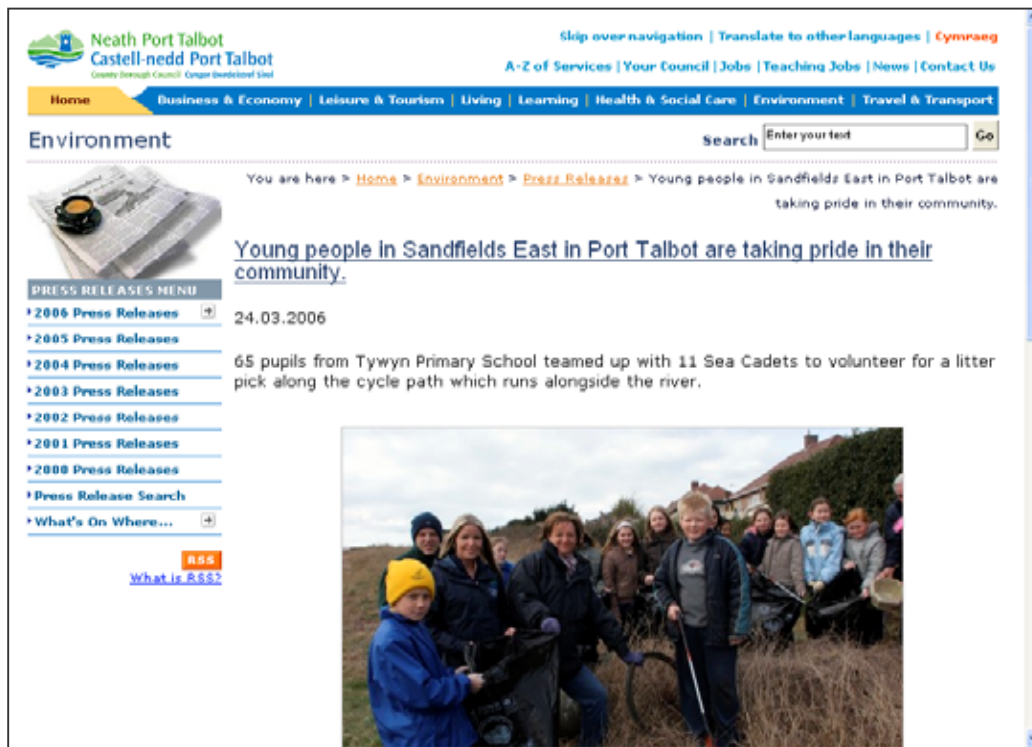

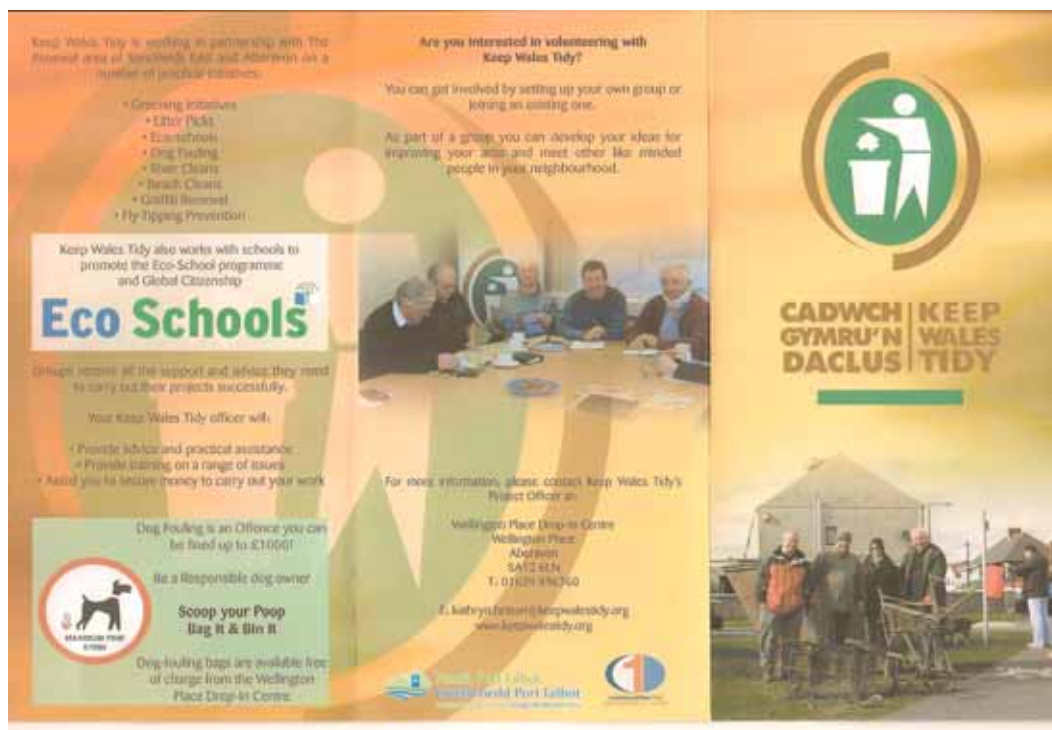



In addition to this, regular articles appear on Neath Port Talbot council website which assists with raising the profile of the work being undertaken.

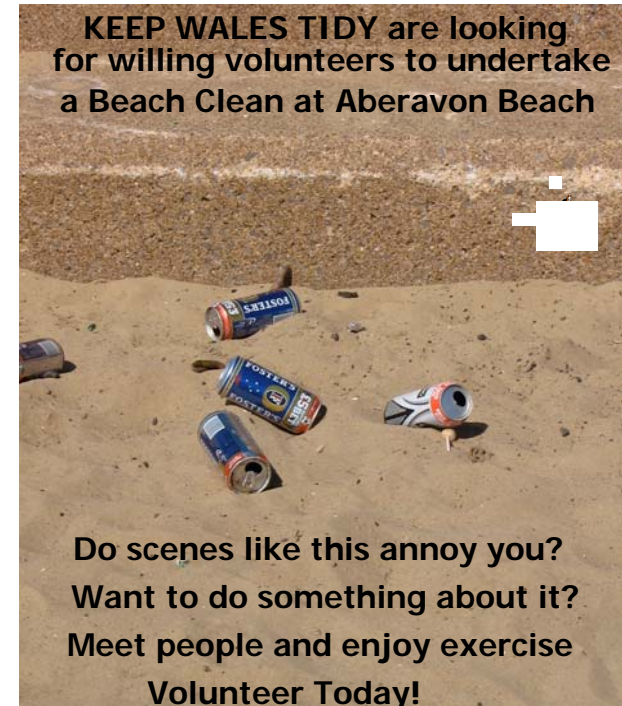
