SLC279 - The Town and Country Planning (General Development Procedure) (Amendment) (Wales) Order 2009

Negative procedure. Date made 18 April 2009. Date laid 21 April 2009. Coming into force date 1 June 2009
This Order amends the Town and Country Planning (General Development Procedure) Order 1995. It makes provision for design and access statements which are required to accompany certain types of planning applications.

SLC280 - The Planning (Listed Buildings and Conservation Areas) (Amendment) (Wales) Regulations 2009

Negative procedure. Date made 18 April 2009. Date laid 21 April 2009. Coming into force date 1 June 2009
These Regulations amend the Planning (Listed Buildings and Conservation Areas) Regulations 1990 to make provision for design and access statements which are required to accompany specified applications for listed building consent.

SLC281 - The Housing Renewal Grants (Amendment) (Wales) Regulations 2009

Negative procedure. Date made 27 April 2009. Date laid 28 April 2009. Coming into force date 20 May 2009

These Regulations further amend (in relation to Wales) the Housing Renewal Grants Regulations 1996, which set out the means test for determining the amount of grant which may be paid by local housing authorities under Chapter 1 of Part 1 of the Housing Grants, Construction and Regeneration Act 1996.

SLC282 - The Products of Animal Origin (Third Country Imports) (Wales) (Amendment) (No. 2) Regulations 2009

Negative procedure. Date made 27 April 2009. Date laid 28 April 2009. Coming into force date 28 May 2009

These Regulations further amend the Products of Animal Origin (Third Country Imports) (Wales) Regulations 2007 to take account of the changes in personal imports permitted from third countries brought about by Commission Regulation (EC) No 206/2009 on the introduction into the Community of personal consignments of products of animal origin. These Regulations also revoke the Products of Animal Origin (Third Country Imports) (Wales) (Amendment) No. 2) Regulations 2006.
