SLC284 - The National Health Service (Charges) (Amendments Relating to Pandemic Influenza) (Wales) Regulations 2009 Negative procedure. Date made 7 May 2009. Date laid 7 May 2009. Coming into force date 8 May 2009

These Regulations amend the National Health Service (Free Prescriptions and Charges for Drugs and Appliances) (Wales) Regulations 2007 and the National Health Service (Charges to Overseas Visitors) Regulations 1989

These Regulations will disapply in Wales the requirement to recover charges from persons supplied with anti-viral drugs under any arrangements to distribute and supply antivirals without prescription.

The Regulations also ensure that overseas visitors will not be required to pay for treatment they receive for pandemic influenza. This reflects the position in England.

The Regulations were made on 7 May 2009. The Counsel General has notified the Presiding Officer (by letter dated 7 May 2009 as corrected on 8 May 2009) of the need to breach the '21 day rule' to bring these Regulations into force on 8 May 2009.
