NATIONAL ASSEMBLY FOR WALES**LEGISLATION COMMITTEE REPORT****The National Health Service****(Dental Charges) Amendment (Wales) Regulations 2000****Background**

Section 79A of the National Health Service Act 1977 enables the National Assembly to make provisions as to the charges made for general dental services.

These regulations increase the maximum charge for dental treatment or appliances under the terms of any one contract or arrangement from £348 to £354. This is done by amending the National Health Service (Dental Charges) Regulations 1989 ("the principal Regulations").

They apply when the contract is entered into or the arrangement made on or after the 1st April 2000.

No points have been identified as matters in respect of which the Committee needs to invite the Assembly to pay special attention.

Comments on the Regulations

As these Regulations are amending existing England and Wales Regulations, consideration should be given to whether or not similar provisions are being made in England. If the same amendments are being made then there is no problem, but if not, then to facilitate clarity each textual amendment should incorporate the words "in Wales".

The structure of Regulation 4 could have been improved to assist understanding by the use of paragraphs.
