The Non-Domestic Rating Contributions (Wales) (Amendment) Regulations 1999

Background

Local Authorities must pay non-domestic rating contributions to the National Assembly for Wales (Schedule 8, Local Government Finance Act 1988).

Rules for calculations of these contributions are set out in the Non-Domestic Rating Contributions (Wales) Regulations 1992.

The rules must be framed so that the amounts paid by the authorities are "broadly the same" as the total payable in respect of the year under sections 43 and 45 of the Local Government Finance Act 1988.

These regulations make minor updating amendments to those rules.

The regulations were made under the urgency procedure on 17 December 1999 and came into force on 31 December 1999.

Standing Order 11.5

It is not considered that there are any issues arising under Standing Order 11.5 that the Committee should report as requiring special attention.

Comments on the Regulations

In view of the lengthy nature of paragraphs 4, 5 and 6 of Schedule 8 to the Local Government Finance Act 1988 (which are referred to in the introductory paragraph), the paragraphs could in some cases have been narrowed to include only the relevant sub-paragraphs .

Two minor typographical errors were identified in the Schedule and incorporated into the final signed copy. "Merthyr" is miss-spelt in the Welsh version, and there is a missing comma "Rhondda, Cynon, Taff" in the English version".

EXPLANATORY NOTE

(This note is not part of the Regulations)

O dan Ran II o Atodlen 8 i Ddeddf Cyllid Llywodraeth Leol 1988 mae'n ofynnol i awdurdodau bilio yng Nghymru dalu symiau (a elwir yn gyfraniadau ardrethu annomestig) i Gynulliad Cenedlaethol Cymru a chynhwysir rheolau i gyfrifo'r cyfraniadau hynny yn Rheoliadau Cyfraniadau Ardrethu Annomestig (Cymru) 1992.

Mae'r Rheoliadau hyn yn diwygio'r rheolau hynny drwy roi fformwla newydd ym mharagraff 4(1) o Atodlen 1 (didyniaadau o'r swm gros), lluosydd newydd ym mharagraff 2(12) o Atodlen 2 (rhagdybiaethau yngln â'r swm gros) ac Atodlen 4 newydd (ffigurau poblogaeth oedolion).

Under Part II of Schedule 8 to the Local Government Finance Act 1988 billing authorities in Wales are required to pay amounts (called non-domestic rating contributions) to the National Assembly for Wales and rules for the calculation of those contributions are contained in the Non-Domestic Rating Contributions (Wales) Regulations 1992.

These Regulations amend those rules by substituting a new formula in paragraph 4(1) of Schedule 1 (deductions from gross amount), a new multiplier in paragraph 2(12) of Schedule 2 (assumptions as to gross amount) and a new Schedule 4 (adult population figures).

Mae Cynulliad Cenedlaethol Cymru'n gwneud y Rheoliadau canlynol drwy arfer y pwerau a roddwyd i'r Ysgrifennydd Gwladol gan adrannau 140(4), 143(1) a (2) o Ddeddf Cyllid Llywodraeth Leol^(a) a pharagraffau 4, 5 a 6 o Atodlen 8 iddi, ac a freiniwyd bellach ynddo i'r graddau y maent yn arferadwy yng Nghymru^(b):

Enwi, cychwyn a dehongli

1.-(1) Enw'r Rheoliadau hyn yw Rheoliadau Cyfraniadau Ardrethu Annomestig (Cymru) (Diwygio) 1999 a byddant yn dod i rym ar 31 Rhagfyr 1999.

(2) Yn y Rheoliadau hyn, ystyr "Rheoliadau 1992" yw Rheoliadau Cyfraniadau Ardrethu Annomestig (Cymru) 1992^(c).

Diwygio Rheoliadau 1992

2. Yngln â'r blynnyddoedd ariannol sy'n dechrau ar neu ar ôl 1 Ebrill 2000, diwygir Atodlenni 1, 2 a 4 i Reoliadau 1992 fel a ganlyn:-

(a) ym mharagraff 4(1) o Atodlen 1, yn lle'r fformwla "(A x £39.50) + (B x 0.00087)" y rhoddir y fformwla "(A x £39.90) + (B x 0.00078)";

(b) ym mharagraff 2(12) o Atodlen 2 yn lle "0.999" y rhoddir "1.005";

(c) yn lle Atodlen 4 i Reoliadau 1992 y rhoddir yr Atodlen a nodir yn yr Atodlen i'r Rheoliadau hyn.

The National Assembly for Wales makes the following Regulations in exercise of the powers given to the Secretary of State by sections 140(4), 143(1) and (2) of, and paragraphs 4, 5 and 6 of Schedule 8 to the Local Government Finance Act 1988^(a), which are now vested in it so far as exercisable in Wales^(b):

Citation, commencement and interpretation

1.-(1) These Regulations may be cited as the Non-Domestic Rating Contributions (Wales) (Amendment) Regulations 1999 and shall come into force on 31st December 1999.

(2) In these Regulations "the 1992 Regulations" means the Non-Domestic Rating Contributions (Wales) Regulations 1992^(c).

Amendment of the 1992 Regulations

2. In relation to financial years beginning on or after 1st April 2000, Schedules 1, 2 and 4 to the 1992 Regulations are amended as follows:-

(a) in paragraph 4(1) of Schedule 1, for the formula "(A x £39.50) + (B x 0.00087)" there is substituted the formula "(A x £39.90) + (B x 0.00078)";

(b) in paragraph 2(12) of Schedule 2 for "0.999" there is substituted "1.005";

(c) for Schedule 4 to the 1992 Regulations there is substituted the Schedule set out in the Schedule to these Regulations.
