# **MINISTER'S REPORT**

### **The Homelessness Commission**

1. The Homelessness Commission was proposed under the terms of the Partnership Agreement "Putting Wales First." It takes forward National Assembly actions to tackle homelessness and rough sleeping in Wales; the substantial increase in resources to address the problems; new secondary legislation to extend the safety net for homeless people; more preventative work and outreach support; better local strategies.

2. The Commission gives a new focus to the National Assembly's work in this area, and will make urgent recommendations to achieve our objectives. It will play a vital role in the development of better, more strategic service delivery, and in targeting the increased investment (£3.5 million extra) through Section 180 over the next three years. The Commission will advise the Assembly on delivering the objectives in "Better Wales", and taking forward the recommendations of the "Rough Sleeping in Wales" report, and the Housing Strategy task groups relating to homelessness and rough sleeping.

3. The Commission will be a "task and finish" group. It will be constituted in November 2000 and will complete the tasks listed by early summer 2001. The Commission will advise the Assembly on:

- Delivering the objectives in "Better Wales" to reduce (by 2003) the "number of homeless families in temporary housing to below 500," for "the need for rough sleeping to be eliminated," and to "improve the access to health services for those sleeping rough and the homeless."
- Taking forward the recommendations in the Assembly report "Rough Sleeping in Wales" and the recommendations of the Housing Strategy task groups relating to homelessness and rough sleeping.
- Delivering local homelessness strategies in all Welsh local authorities.
- Setting targets and outcomes.
- Measuring homelessness and rough sleeping and to advise the Office for National Statistics in relation to the count of rough sleepers in Wales on census night 2001.
- The options for the long term funding for homelessness services in Wales, particularly in

relation to "Supporting People."

Its tasks will be to:

- Map current information on homelessness and rough sleeping in Wales, and existing and planned provision, and identify gaps and overlaps.
- Devise a common methodology for counting rough sleepers in Wales.
- Consider definitions of homelessness and rough sleeping and propose definitions for Wales.
- To consider how to monitor single homelessness across Wales
- To consider targets (and the feasibility of targets) and outcomes for tackling homelessness and rough sleeping in Wales.
- To review and evaluate best practice in tackling homelessness and rough sleeping, and to publish the review on the Assembly website.
- To develop a model local authority homelessness strategy.

4. Peter Black will chair the Commission. I will also be inviting the chairs of the Local Government and Housing and Health and Social Services Committees to become members. I will announce further details of the membership very soon.

### Local Authority Visits

5. I visited Wrexham on 24 November to meet the Leader and Chief Executive of Wrexham County Borough Council and to see a regeneration project. On 30 November I shall meet the Leader and Chief Executive of Neath Port Talbot and I shall be in Powys on 6 December to meet the Leader and Chief Executive there.

### **Disaggregation of Police and Local Authority Budgets**

6. I have asked officials to advise on the implications of disaggregating police and local authority budgets. I want to make decisions about Assembly block grant support to both more visible, and disaggregation would enable the Assembly's decisions about police support to be transparent. Meanwhile, I will announce headline support for the police, in line with a parallel announcement by the Home Secretary, on Monday 27 November.

## Study on Councillors' Allowances

7. I have decided to expand the scope of the study into Councillors' Allowances.

8. This is a valuable opportunity to look, not just at Councillors' Allowances, but at ways in which we can encourage and support a more diverse cross-section of the population to become Councillors.

9. There is a need to involve the young, people from deprived areas, minorities and all underrepresented groups in shaping a council's policy.

10. The study will look at all the various issues which might hinder people becoming councillors and ways to overcome them: e.g. paying employers to release staff; pensions; e-mail access, claims for using own computers, travel and subsistence.

#### **Best Value Performance Indicators**

11. I was grateful to the Committee for supporting the principle of reducing the number of best value performance indicators, and for their comments on individual indicators. The consultation paper to be issued shortly reflects both the general view, as well the specific comments.

12. The Welsh Local Government Association also suggested a reduction of a further 20 indicators, the majority of which have been accepted. Only where it was felt that deletion would result in the importance of individual services being perceived as having a reduced prominence have we retained them. This is especially so in those on the cultural elements of local authority provision.
