Item 1: Apologies for absence: Janice Gregory, Jeff Cuthbert, Ann Jones

Item 2: Minutes of the Previous Meeting – LEG(2)-19-2006

2.1 The Committee agreed the minutes of the meeting held on 20 June 2006.

Item 3: Chair's Report

3.1. As there were no items to report the Chair moved directly to discussing legislation.

Item 4: Assembly Orders for Consideration

4.1 LC1308 – The Planning (National Security Directions and Appointed Representatives) (Wales) Regulations 2006

Mr Griffiths presented the report to the Committee. It was noted that there were several minor points reported under Standing Order 11 in respect of these Regulations, but as this Statutory Instrument had been made under the Executive Procedure there was no way to correct them apart from when amending legislation was made. It was noted that it was difficult for the Committee to check when the relevant corrections were made. It was suggested that post-2007 the National Assembly for Wales might want to adopt an approach similar to that of Westminster: they keep a record of all corrections to be made and check their implementation annually before writing to relevant Ministers.

- 4.2 It was also queried why it was necessary to make these Regulations under the Executive procedure. The Legal Adviser explained that this Statutory Instrument had to be made by the date the related primary legislation came into force. However, the question remained why the drafting of this SI had not been started earlier to make it possible for it to follow the standard procedure.
- 4.3 It was also noted that the primary legislation to which these Regulations related gave powers to the Assembly's Counsel General. As there was currently no Counsel General, it was queried whether these Regulations would be valid. The Legal Adviser explained that they would, but that the relevant powers cold not be exercised until there was a Counsel General. The Members agreed that the report should be made in the form of the draft presented to the Committee by the Legal Advisers.

4.4 LC1310 - The Town and Country Planning (Miscellaneous Amendments and Modifications relating to Crown Land) (Wales) Order 2006

Mr Griffiths presented the report to the Committee. It was noted that this Order applied to the National Assembly as currently constituted, and would continue to apply to the Welsh Assembly Government.

4.5 It was noted that currently the National Assembly was a Crown Body and post 2007 the Welsh Assembly Government would be a Crown Body. The Legal Adviser explained that the post-separation Assembly could be designated a Crown body for certain purposes. That would be done by an order made by the Secretary of State. The matter was currently being considered by the Assembly Parliamentary Service and in due course would be considered by the Shadow Assembly Commission. The Members agreed that the report should be made in the form of the draft presented to the Committee by the Legal Advisers.

4.6 LC1329 – The Assembly Learning Grants (European Institutions) (Wales) Regulations 2006

Ms Jackson presented report to the Committee. It was queried why these Regulations provided for support for students taking designated higher education courses at only three specified institutions. The Assistant Legal Adviser promised to find out. Action: Assistant Legal Adviser/Clerk. The Members agreed that the report should be made in the form of the draft presented to the Committee by the Legal Advisers.

4.7 LC1331 - The Road Traffic (Permitted Parking Area and Special Parking Area)(County Borough of Conwy) Order 2006

It was noted that this Order designated Conwy as both a permitted parking area and a special parking area and it was consequently queried if Denbighshire was also designated as a permitted/special parking area. The Legal Adviser explained that it was a matter for local authorities to make an application; Conwy local authorities made one but he had no information regarding Denbighshire. The Clerk promised to find out. Action: Clerk

The Members agreed that the report should be made in the form of the draft presented to the Committee by the Legal Advisers.
