Letter from Elin Jones, the Minister for Rural Affairs on the Common Agriculture Policy: Penalties imposed on farmers

Common Agriculture Policy: Penalties imposed on farmers

Thank you for your letter of 3rd March 2010 requesting details of the sum total of penalties imposed on farmers in European agriculture schemes for irregularities in paper work or minor breaches of European regulations in each of the four previous financial years split by individual cases and categories.

Payments are made to farmers on a scheme year basis not financial year, so the data has been provided for the last four scheme years. The data has been split between the categories of penalty we are required to record under the various regulatory requirements which I trust will be sufficient to aid the committee in its consideration of this matter.

You will notice that the total cost of penalties has increased significantly in 2009 and that this is due to cross-compliance penalties. The vast majority of these penalties are down to cattle identification or movement breaches. Even with this increase the value of the penalties in 2009 represents only 0.6% of the total value of subsidies paid in 2009.

This increase results from changes made to our penalty system following an EC Audit held in December 2008, which was critical of the level of financial reductions applied for breaches of Cross Compliance requirements in years prior to and including 2008. The penalty system now meets the audit and regulatory requirement that, as a general rule, negligent breaches must be penalised at 3%.

In addition, the EC audit stated that they 'consider that if the farmer had been warned about the practice (i.e. a breach), then it could not be considered as a negligent oversight'. Changes were therefore made to the application of 'intentional' which has resulted in an

increase in the number of penalties being applied as intentional, specifically with regards to the requirement to replace cattle ear tags within 28 days.

An example of an intentional breach is, where cattle are found to have missing ear tags during an inspection, the farmer is issued with a written notification stating that ear tags must be replaced within 28 days, inline with regulatory requirements. Post inspection follow-up checks are undertaken to ensure that new ear tags had been ordered within 28 days, if they have not then an intentional penalty would be applied due to the risk to human and animal health.

In addition EC legislation requires a 100% penalty where the same intentional breach is found on a second occasion (i.e. repetition) during inspection or admin checks – we would have no discretion in the handling of such cases.
