Background

3. The Committee last met on 12 May. This paper provides an update.

First Minister's International Activities

12 May Lunch with the delegation from the Silesian Union of Municipalities and Districts - Along with other members of the Committee I joined the delegation for lunch which provided the opportunity to continue discussions following the earlier presentation.

16 May Meeting with Ambassador HE Indulis Berzins, Latvian Ambassador to the UK - I met His Excellency Indulis Berzins, Latvian Ambassador to the UK on his first visit to Wales. This was both a courtesy call and an opportunity to discuss the MOU between Wales and Latvia. The meeting was one element of a programme that included meetings with the Minister of Culture, Language and Sport, Assembly Government Officials and those from the wider partnership.

18 May Meeting with Ambassador HE Bela Szombati, Hungarian Ambassador to the UK - I met His Excellency, Bela Szombati on a courtesy call to build upon the cordial relationship with the Embassy. Amongst other issues we discussed the opportunities to develop trade between Wales and Hungary and this will now be taken forward by Wales Trade International.

19 May Meeting & Lunch with the Saudi Ambassador HE HRH Prince Turki Al-Faisal - Along with the

Minister of Culture, Language and Sport, Business Minister and the External Relations VIP Visits Team I met with the Saudi Ambassador - His Excellency HRH Prince Turki Al-Faisal on his first visit to Wales, the first Saudi Ambassador to visit Wales for at least 20 years.

19 and 20 May Attendance at the British Irish Council Meeting - I attended this meeting which was held in the Isle of Man and discussed Telemedicine with colleagues from other administrations. I will issue a Written Statement about the proceeding and circulate the final Communiqué to all AMs.

23 May Meeting & Lunch with the Argentinian Ambassador HE Mr Federico Mirre - I met and had lunch with the Argentinian Ambassador His Excellency Frederico Mirre and discussed a range of issues. The Ambassador also held discussions with Wales Trade International about the trade mission scheduled to visit Argentina later in the year. The Argentine Embassy hosted a food tasting in the canteen in Cathays Park. Rocky Trip, a new book charting the development of the Welsh colony in Patagonia was launched by the Minister for Culture, Welsh Language and Sport and the day ended with all parties attending the British Lions/Argentina Rugby match.

8 June Meeting & Lunch with HE Vahe Gabrielyan, Armenian Ambassador - I met with His Excellency Vahe Gabrielyan on his first visit to Wales.

13 June Address to the 'World Comes to Wales' Diplomat Conference - I addressed delegates including over 20 Ambassadors and High Commissioners at the 'World Comes to Wales' Diplomat Conference held in Cardiff for the first time after previously being held in Edinburgh and Belfast.

General Correction Mechanism

This note has been prepared by HM Treasury.

Calculation of the current UK rebate

The Financial Perspective process sets the overall EU budget envelope for a seven-year period. Member States' contributions to the financing of the budget are determined separately by the Own Resources Decision, which, unlike the FP is not time limited. The current ORD sets out the sources three sources of funding to the budget - Traditional Own Resources (customs duties, levies on agricultural products), the VAT-based resource and the GNI-based resource. The ORD (and supporting documents) also defines the correction that is applied to Member States' shares of financing of the budget to give the UK its abatement, a well as the 'abatement on the abatement' for DE, SE, NL and AT.

The UK abatement is calculated a year in arrears. The rebate received in 2005 will be equal to 66% of the difference between the UK gross contribution to the EU budget and total receipts in 2004. The definitions of gross contributions and receipts used in the calculation of the rebate are complicated but

this basic definition still holds. These complexities are the same issues that cloud the calculation of net balances: the 'Commission method' for net balance calculations systematically underestimates net contributions, especially for the UK and NL. We therefore use the more straightforward 'accounting method'.

The UK rebate (as with the other corrections described in this paper) works on the financing side of the budget. Financing the budget is a zero-sum game that is independent of the size of the budget. Therefore although the value of the abatement is affected by expenditure policy it does not itself alter the overall budget: the rebate alters all Member States' financing shares and does not score as a receipt to the UK.

The Commission proposal

The Commission proposed in July 2004 to replace the UK abatement with a 'Generalised Correction Mechanism'. In the GCM, all net contributors receive a rebate equal to 66% of their net contribution above a threshold of 0.35% GNI (i.e. a country with a net balance of 0.40% of GNI would receive a rebate equal to 66% of 0.05% GNI). The Commission proposal however suggested limiting the total amount of rebates available to all net contributors to EUR7.5bn. If Member States together qualify for rebates totalling more than this amount the 66% is reduced to scale the total down to EUR7.5bn.

Needless to say this would be very expensive for the UK. Instead of receiving a rebate of 66% of its net contribution it would receive a rebate of 66% of its net contribution over 0.35% - less if the total rebate maximum were reached. In addition, the cost of the UK rebate is currently split between the other 24 Member States. Under a GCM the UK would contribute to its own rebate in proportion to the UK share of EU GNI. Overall the effect would be to double the UK annual net contribution by 2013.

The UK government has rejected the GCM as a replacement for the abatement. First, the abatement does not need replacing: given the continuing inequities and inefficiencies on the expenditure side of the budget the abatement is fully justified and not up for negotiation. Secondly, the GCM does not, as the Commission claims, make Own Resources any "fairer" - in fact it widens the already considerable disparities between net contributors to the EU budget and ignores the continuing anomaly whereby we have some very rich net recipient member states.

Note on Policing EU events

This note has been provided by the Home Office and the FCO.

In general terms a Special Grant may be considered when the additional costs

incurred by a force are more than 1% of a police authority's annual budget. This

threshold may be waived for security policing. Police authorities are not automatically

entitled to Special Grant and decisions regarding its allocation are made at the Home

Secretary's discretion.

Examples of approved requests are: for policing the main party conferences, special investigations like Soham, national events like the Millennium Stadium costs for football.

Police authorities should write to the Home Office outlining their case for additional funding.

In the case of UK Presidency events, there is no policy for making additional funding available to the police other than through the Special Grant arrangements.

UK Presidency of the EU 2005

Cardiff Youth Event

- 1. The Welsh Assembly Government on behalf of the UK Presidency is hosting the Youth Event at Cardiff City Hall over 24-27 October 2005. The event will coincide, and link up with, a meeting of Director Generals (Youth) on 27-28 October 2005.
- 2. Youth Events are held in each Presidency and aim to give young people a voice in European policy-making. The Cardiff Youth Event will encourage the exchange of information, experience and good practice in promoting the participation of young people in civic life a priority theme within the process of European co-operation on youth policy, known as the open method of co-ordination (OMC). The European Commission largely drives the theme, however there is scope for the Presidency to tailor the discussions to reflect local practice in the UK and other member states. We will be using this opportunity to focus on participation in Wales wherever possible.
- 3. The focus will be the participation of young people in civic life the life of their communities, the local, the regional and the grassroots effectively grounding what is a high level process in the concrete reality of youth participation at local and/or regional level. If the common objectives are to be achieved, local and regional level actors must be fully engaged.
- 4. It also sits within the overarching "Achieving the Lisbon goals" theme of the UK Presidency as the event will highlight: how young people's participation in local life contributes to the their acquisition of skills and competencies, relevant to the work place, and can help combat social exclusion.
- 5. The 'selection' of young people who attend these events is largely out of our control since the criteria is determined by the European Commission, which is also the principal funder. Each member state is allocated space for two young people one from a recognised national youth organisation and one from local community level. This does not fit with the internal political geography of some member states and

can and does cause difficulties. For example, the UK's structure adds up to 4 representatives. An added factor is that the 'core' of the youth event is always made up of representatives from the European Youth Forum (EYF). As the internal constitution of the EYF follows the constitution of the EU - 25 member states - it cannot reflect the actual political geography of many member states. The EYF also tends to attract young people who are very active in European political circles and have an eye to a future job in that area.

6. With this in mind we have broken tradition and negotiated with the EU Commission an additional 20 delegates from the UK (8 from Wales; and 4 from each of the other home countries. Notably, the Commission has also agreed to fund these places. We are now working on ensuring that these young people come from a diverse range of backgrounds. The last thing we want to see is an elitist event.
