WRITTEN STATEMENT BY THE WELSH GOVERNMENT

TITLE Ministerial Overseas Visit to Dublin, Ireland

DATE 15 February 2024

On the 25th and 26th January 2024, I visited Dublin to attend a British and Irish Council Ministerial Meeting on Drugs & Alcohol.

The British Irish Council was formed as part of the multi-party agreement reached in Belfast on 10 April 1998. Its membership comprises representatives from the Irish Government; UK Government; Scottish Government; Northern Ireland Executive; Welsh Government; Isle of Man Government; Government of Jersey and Government of Guernsey. Its primary aim is to further promote positive, practical relationships amongst its participant nations and to provide a forum for consultation and co-operation.

The purpose of the meeting I attended was to allow Ministers to review recent activity of the British Irish Council's workstream on Drugs and Alcohol and to discuss a proposed new forward work plan. I also had the opportunity to undertake a Bilateral meeting with Minister Hildegarde Naughton TD of Department of the Taoiseach with special responsibility as Government Chief Whip; and the Department of Health with special responsibility for Public Health, Wellbeing and the National Drugs Strategy.

On arrival in Dublin I attended, with other Ministers, a showcase event with representatives of projects and organisations active in a number of areas including prevention, drug related violence and overdose. This also featured a discussion on 'Preparing and Responding to the emergence of Synthetic Opioids' with Professor Eamon Keenan, the Clinical Lead for Addiction in the Irish Health Service.

The second day began with the Bilateral with Minister Naughton where I was able to detail and discuss the Welsh Government experience of the national implementation of injectable buprenorphine (Buvidal) as a treatment for heroin users in Wales.

I then attended the Ministerial meeting alongside the Ministers for Ireland and Guernsey who attended in person, we were also joined virtually by the Scottish, Jersey and Isle of Man Ministers. The meeting was used to review the recent activity of the BIC Drugs and Alcohol Work Sector including Drug Related Deaths, the Covid-19 Impact on substance misuse and work around Financial Mechanisms for Alcohol. We also discussed a proposed new Forward Work Plan. The meeting concluded with a presentation by Paul Reid, Chair of the Irish Citizens' Assembly on Drugs on Deliberative Democracy.

I found the visit to Dublin to be of huge benefit and we will continue to engage with our partners in the British and Irish Council. The Council gives us the ability to share our learning and look at new approaches that can be undertaken to tackle substance misuse in Wales and across all administrations.

This statement is being issued during recess in order to keep members informed. Should members wish me to make a further statement or to answer questions on this when the Senedd returns I would be happy to do so.

I am writing in response to your letter of 18 January regarding the agreement under the United Nations Convention on the Law of the Sea on the Convention and Sustainable Use of Marine Biological Diversity of Areas Beyond National Jurisdiction (the BBNJ Treaty).

In September 2023, UK Ministers wrote to the Minister for Climate Change to notify her about the agreement. The Minister was asked to consider any implications of the Treaty on the Welsh marine zone. No further inter-Ministerial correspondence has been received about this matter.

Officials are considering the policy requirement for legislation and have notified legal services, however, capacity to consider this is limited. At this stage, the requirement for Welsh legislation is not clear, as the Welsh marine zone does not have any direct access to Areas Beyond National Jurisdiction (ABNJ). It is, therefore, unlikely that any proposals within the ABNJ would have any impact on the Welsh Marine Protected Area Network. Additionally, there is little evidence to suggest the Welsh fishing fleet operate within the ABNJ.

We have duly provided the UK Government with an official point of contact and agreed to support any progressional work when appropriate. However, beyond the initial September 2023 correspondence, further inter-governmental work has not taken place. It is not clear at this stage if the UK Government has progressed this matter further.

Agreement under the United Nations Convention on the Law of the Sea on the Conservation and Sustainable Use of Marine Biological Diversity of Areas Beyond National Jurisdiction ("BBNJ treaty")

As you are aware, the <u>Legislation</u>, <u>Justice and Constitution Committee</u> is responsible for monitoring the implementation of non-trade international agreements in the Sixth Senedd.

During our meeting on <u>4 December 2023</u>, we considered the Agreement under the United Nations Convention on the Law of the Sea on the Conservation and Sustainable Use of Marine Biological Diversity of Areas Beyond National Jurisdiction ("BBNJ treaty"). The BBNJ Treaty provides for the conservation and sustainable use of marine biological diversity of areas beyond national jurisdiction through effective implementation of the relevant provisions of the United Nations Convention on the Law of the Sea and international cooperation.

As you are aware, although foreign affairs and international relations are reserved matters, observing and implementing international agreements in devolved areas is not reserved. As noted in our <u>report</u>, the Treaty also relates to fisheries, marine, and environmental policy, which are matters devolved to Wales.

The Explanatory Memorandum details the intergovernmental engagement which took place in relation to the agreement, including updating and consulting the devolved governments on the agreement's development.

We would be grateful if you could please provide:

• your view of the process of updating and consulting the devolved governments on the agreement's development;



- an update on legislation required to implement the agreement; and
- information on any intergovernmental work taking place, or due to take place, to implement the agreement, as well as confirmation of which existing intergovernmental structures are being utilised.
