3 New Petitions

In line with the practice adopted by previous Petitions Committees, the Committee agreed that a written response will be sought from the Welsh Government, or another relevant organisation, in advance of its first consideration of new petitions in future.



3.1 P-06-1158 The Welsh Government to put in place a dedicated disability Minister within the next term of Government

The Committee considered the petition for the first time and agreed to write to the First Minister to seek a response to the issues raised by the petition.

3.2 P-06-1159 Finally ban the manufacture, sale and use of animal snares in Wales

Luke Fletcher MS declared the following relevant interest under Standing Order 17.24A: He supported this cause during his election campaign.

Joel James MS declared the following relevant interest under Standing Order 17.24A: He is a member of The British Association for Shooting and Conservation (BASC).

The Committee considered the petition for the first time and agreed to write to the relevant Minister to seek a response to the issue raised by the petition and a timescale for the proposed ban.

3.3 P-06-1160 Require local Welsh exam centres to accept home-educated students for public exams

The Committee considered the petition for the first time agreed to write to the Minister for Education and the Welsh Language to seek a response to the petition.

3.4 P-06-1161 Routine collection and publication of data of how many

3.5 P-06-1162 Break up the County of Rhondda Cynon Taff and join the Cynon Valley to Merthyr County

The Committee considered the petition for the first time and agreed to write to the:

- Centre for Alternative Technologies asking whether they have sought designation as a Higher Education Institute from the Welsh Government for this and other courses, or whether they intend to do so in the future.

3.8 P-06-1165 Ban the sale and consumption of alcohol within the Senedd

The Committee also agreed there was little further action is could undertake on the petition given its remit, and therefore agreed to close the petition and thank the petitioner for raising the issue.

The Committee considered the petition for the first time and considering the Welsh Government previously rejecting proposals for pupils to repeat the school year and the alternative recovery plan that it has published the Committee agreed to: write to the Minister for Education and the Welsh Language to seek an update on the issues raised in the petition; and

once a response is received from the Minister it agreed to close the petition and thank the petitioner.

3.12 P-06-1169 Let Welsh citizens vote on lockdown restrictions

The Committee considered the petition for the first time and noted that there was little further action it could undertake on the issues raised in the petition. As such, the Committee agreed to close the petition and thank the petitioner.

3.13 P-06-1170 An immediate independent review of the Tier 1 and Tier 2 selection

process in the WPWL

Luke Fletcher MS declared the following relevant interest under Standing Order 17.24A: He is a co-submitter on a relevant <u>statement of opinion</u>.

The Committee considered the petition for the first time and agreed to write to both the Deputy Minister for Arts and Sport and the Football Association of Wales to seek their views on the issues raised in the petition.

4 Updates to previous petitions

4.1 P-05-914 Equal Access to Health Care for the Disabled

The Committee considered the correspondence received and the work undertaken by its predecessor Committee and agreed to produce a short report on the issues raised within the petition.

4.2 P-05-974 Ensure the technology of prosthetic limbs provided within the Welsh NHS is equal to the rest of the UK

The Committee considered the correspondence received and agreed that the petition has achieved its aim to ensure funding for limb amputees to have prosthetic technology equal to that available within the English and Scottish NHS. It therefore agreed to close the petition and congratulate the petitioner on the positive outcome achieved. The Committee also agreed to produce a case study to showcase how petitions can make a difference.

4.3 P-05-1078 Increase funding for mental health services and improve waiting times for people needing help in crisis. We need a change!

The Committee considered the correspondence received, and noted that the petition had been debated in Plenary in the last Senedd and agreed to thank the petitioner for raising the issue and to share a recap of the debate with the petitioner. Members recalled strong campaigns for 24h access to Mental Health service during the election campaign – and agreed to write to the Minister for Health and Social Services seeking an update on that related issue.

4.4 P-05-1147 Require all schools to provide daily live / recorded teaching to all pupils not returning to school

The Committee considered the correspondence received and noted that the then Minister clearly stated that decisions regarding live or recorded lessons are a matter for the school and local authority. Consequently, there was little further action it could undertake. It agreed to close the petition and thank the petitioner for raising the issue and to suggest they contact their school or local authority directly if they wished to take the matter forward.

4.5 P-05-1013 Provide financial support for self-employed individuals within the

Welsh live music industry

The Committee considered the correspondence received and concluded, that with regret, there was little further action it could undertake on the issue and therefore agreed to close the petition and thank the petitioner.

4.6 P-05-1092 Do not delay the May 2021 elections

As the timeframe noted in the petition has lapsed the Committee agreed to close the petition and thank the petitioner.

4.7 P-05-1150 Provide business rates holiday to holiday home sites in wales, the same as England
