SL(6)047 – The Education Tribunal for Wales (Amendment) Regulations 2021

Procedure: Affirmative

These <u>Regulations</u> correct a cross-referencing error in the Education Tribunal for Wales Regulations 2021 ("the Tribunal Regulations").

The Tribunal Regulations set out the procedure to be followed in proceedings before the Educational Tribunal for Wales concerning additional learning needs appeals (under Part 2 of the Additional Learning Needs and Education Tribunal (Wales) Act 2018) and claims of disability discrimination in respect of school pupils (under Chapter 1 of Part 6 of the Equality Act 2010).

These Regulations substitute a new regulation 17(2) of the Tribunal Regulations to provide that the case statement period for a claimant making a claim under the Equality Act 2010 is 8 weeks beginning on the date that the acknowledgment of receipt of a claim is received.

We are delighted to see that the Senedd has set up a legislation, Justice and Constitution committee and congratulate you on being elected Chair.

As the Diverse 5050 campaign, our target is to build a diverse culture in terms of representation and leadership in the Senedd and in the Welsh political structure, increasing diversity of representation for LGBT+ people, people of colour, and disabled people. A Senedd reflective of the whole population of Wales. Specifically, we are asking for:

- A process that will deliver an enlarged Senedd;
- legally binding integrated diversity and gender quotas;
- A Senedd elected by the STV voting system

For us, diversity shouldn't be a gap that needs to be filled but should be a culture and practice for all. It is who we are, where we grew up surrounded by different faces, voices, experiences, and languages. We want to see decision-making in Wales thoroughly informed by the perspectives and lived experiences of people who are women, men, disabled, racialized, LGBTQ+ and young people as this will produce better policy outcomes for all.

One of the Committee on Senedd Electoral Reform <u>recommendations stated</u>: 'The relevant Sixth Senedd committee should undertake further work on diversity quotas in respect of characteristics other than gender to inform decisions on whether such quotas would be appropriate mechanisms to encourage the election of a more diverse Senedd. This work should be informed by expert advice on the design and operation of diversity quotas, and by working closely in partnership with underrepresented groups, including BAME communities in Wales and people with disabilities.'

Whilst we know that the process to progress the next step of this reform is yet to be ascertained, we, however, ask for your support to actively pursue this change, which is much needed now in our Senedd, or to undertake the inquiry in your committee if no other process is established.

WORK PROGRAMME

Thank you for your letter of 5 July 2021 on behalf of the Royal College of Speech and Language Therapists raising the possibility of a short inquiry into the speech, language and communication needs of young people in the youth justice estate.

We considered your letter at our meeting on 12 July and agreed to consider proposals for future work as part of our strategic planning in the autumn term.

Since that meeting, the Business Committee has written to us indicating where the responsibility for justice should sit within the Senedd Committee structure. It has advised that high-level justice policy matters, such as the devolution of justice and policing, and any matters which relate to law-making, fall within our remit. Other matters relating to the practical application of justice should be open to scrutiny by other Senedd Committees, including the wider policy interactions with the justice system and policing that currently exist.

We will consider the Business Committee's correspondence in early September as we shape our work programme for the first year. However, we do expect the programme to be heavily focused on legislative scrutiny in light of the Welsh Government's recent legislative programme announcement.

Dear Mr Irranca-Davies,

Many congratulations on your appointment as chair of the new Legislation, Justice and Constitution Committee. I am writing as Head of Wales Office for the Royal College of Speech and Language Therapists. I appreciate the wide-ranging remit of the committee and the many calls on the committee's time but wanted to take an early opportunity to raise the possibility of a short inquiry into the speech, language and communication needs of young people in the youth justice estate. As the facts below highlight, this is a significant issue which could benefit from a timely, focused review.

Key facts

- Up to **60%** of young people in the youth justice estate have speech, language & communication needs (Bryan et al, 2007).
- **66%-90%** of young offenders have low language skills. 46-67% of these are in the poor or very poor range (Bryan et al, 2007).
- Around **40%** of young offenders find it difficult or are unable to access and benefit from rehabilitation programmes that are delivered verbally, such as drug rehabilitation courses (Bryan et al, 2004).

To our knowledge, this issue was last reviewed by the Senedd over ten years ago when the then Communities and Culture Committee report 'Youth justice: the experience of Welsh children in the secure estate' (2010) highlighted a lack of provision in Wales for young and adult offenders who have speech language and communication needs and recommended the Welsh Government enable pilot work to be done in Wales on the potential benefits of speech and language therapy for juvenile offenders both in custody and on release. Despite evidence from the pilots, provision remains extremely patchy over a decade later. This was briefly touched upon by the recent Health Committee inquiry on the provision of health and social care in the adult prison estate in Wales in which the governor of HMP Parc acknowledged that there was unmet need for speech and language therapy among the prison population.

We believe a potential short inquiry by the committee could be extremely helpful in shining a light on this key area and would be happy to provide further information to the committee should you wish to explore this possibility further.
