 - To provide information on a strategy that pulls together the causes of debt and poverty, particularly relating to the national insurance increase, universal credit cuts and fuel poverty.
 - To provide more information on the role of the equalities data unit.
 - To provide more information on how the Welsh Government supports those in work who are pushed into debt, but do not qualify for government support.
 - To send information of the Welsh Government view on debt bonfires.
 - To confirm whether the six month notice period currently in place is to be extended until the Renting Homes Act 2016 comes into force and what assessment has been made of what may happen if there is a gap until the Act comes into force.
 - To provide more information on what the government is doing to support victims of domestic abuse who may have debt problems.
