Wednesday

At the request of the Government, Business Committee agreed that the opposition debates be re-ordered to facilitate the Deputy Minister for Mental Health & Wellbeing to respond to the Welsh Conservatives debate on mental health, as reflected below:

- Plaid Cymru debate: HS2 consequential funding (60 mins) re-ordered to item 7
- Welsh Conservatives debate: Mental health (60 mins) re-ordered to item 8
- Voting Time will take place before the Short Debate
- Plenary is unlikely to run past 7.10pm.
