4 Legislation

4.1 Timetable for the Senedd Cymru (Electoral Candidate Lists) Bill

The Business Committee considered the timetable for the Bill proposed by the Government and agreed:

- to refer the Senedd Cymru (Electoral Candidate Lists) Bill to the Reform Bill Committee for consideration of the Bill's general principles;
- to consult with the Reform Bill Committee on the proposed timetable for scrutiny of the Senedd Cymru (Electoral Candidate Lists) Bill and to return the matter at the next meeting; and
- also agreed in principle, and subject to the Senedd agreeing the general principles of the Bill, to table a motion at the start of Stage 2 seeking the Senedd's agreement for Stage 2 proceedings to be undertaken by a Committee of the Whole Senedd.

4.2 Expedited timetables for Senedd Bills

The Business Committee considered a paper on expedited timetables for Senedd Bills. The Committee noted the experience of the two Bills outlined in the paper and requested that officials draft a decision-making tool that could be used to assist it to make future decisions on timetables for Bills when an expedited timetable has been proposed.

Darren Millar requested that consideration be given to the length of time available to Members to prepare for Stage 2 and Stage 3 proceedings on Bills following the tabling deadlines for amendments. Business Committee asked officials to provide a note concerning these matters, to include the recent experience of the Infrastructure (Wales) Bill.

4.3 Letter from the Chair of the Legislation, Justice and Constitution Committee regarding the Renters (Reform) Bill LCM

Business Committee agreed the request to revise the deadline for committees to report on Legislative Consent Memorandum on the Renters (Reform) Bill to 26 April 2024.

6.1 Committee Chair Job Sharing: Detailed Proposals

Business Committee returned to consider the issue of whether to take forward consideration of Committee Chair Job Sharing in advance of the Easter recess, and potential committee chair vacancies which may arise because of the new First Minister appointing their government. A majority on Business Committee agreed that a longer period of time is required to give the relevant matters full consideration.
