To propose that the National Assembly for Wales

- 1. Recognises the additional investment made in the draft budget to the health service arising from the pressure applied by the Welsh Conservatives; and
- 2. Calls on the Welsh Government to redraft their Draft Budget for 2014-15 so that it:

- a) protects the health budget in real terms and fully addresses the extreme financial pressures facing local health boards in Wales;
- b) meets the needs of businesses across Wales, for the benefit of the Welsh economy;
- c) addresses the funding challenges facing FE colleges, so that they can provide a full range of skills and vocational courses for learners in Wales.

Amendment 2 - Elin Jones (Ceredigion)
