4 The Well-being of Future Generations (Wales) Bill: Committee Correspondence

- 4.1 Members considered the correspondence and were supportive of the Environment and Sustainability Committee's request for the Auditor General for Wales to make arrangements to examine the data underpinning the RIA set out in the Welsh Government's Explanatory Memorandum to the Well-being of Future Generations (Wales) Bill.
