The Presiding Officer also said that she very much hopes that over the course of the next 1,000 meetings, the Assembly will see many more changes, including a settlement that is clearer and easier to understand, greater control by the Assembly over its own internal affairs and procedures, and an increase in the number of AMs to reflect the Assembly's enhanced responsibilities.
