4.1 Letter from the Health and Social Care Committee: Safe Nurse Staffing Levels (Wales) Bill

The Chair of the Health and Social Care Committee (HSC) wrote to the Business Committee to request an extension of the deadline for Stage 1 consideration of the Safe Nurse Staffing Levels (Wales) Bill to allow them to hear more evidence.

Business Managers agreed the proposed extension of the deadlines to complete Stage 1 proceedings from 10 April 2015 to 8 May 2015 and with an associated extension for the Committee to complete any possible Stage 2 proceedings from 5 June 2015 to 17 July 2015.
