2.3 P-04-674 Say NO to Dyfed

William Powell declared the following interest under Standing Order 17.24A:

3.1 P-04-658 The Brimmon Oak

- The Committee considered correspondence from the petitioners and agreed to write to the Minister to seek her views on the petitioners' further comments and specifically their concerns about:
 - o the badger proof fencing which will potentially endanger the root system;
 - the lack of knowledge about the registration of the tree with the Woodland Trust in 2009; and
 - the nature of the 'minimal work' needed within the 15 metre tree root protection zone.

3.2 P-04-565 Revive Disused Railway Lines for Leisure

The Committee considered correspondence from the Minister and agreed to close the petition.

3.3 P-04-416 North-South Rail Services

The Committee considered correspondence on the petition and agreed, given that it seems unlikely that further progress can be made on this petition in the near future, to close it.

3.4 P-04-486 Act Now and Help Save the High Street Shops

The Committee considered correspondence from the petitioner and agreed to close the petition. In doing so, they also agreed to write to the Minister seeking an update for the petitioner on the latest position in relation to the small business rate relief scheme.

3.5 P-04-363 Town Centre Improvement Scheme for Fishguard

3.8 P-04-606 Ensure Schools Exercise their Statutory Powers Under Regulation 7 of the Education (Pupil Registration) (Wales) Regulations 2010 Without Interference or Bias.

The Committee considered correspondence on the petition and agreed to keep a watching brief on the petition to allow the incoming Petitions Committee to consider whether any further action might be necessary at that stage.

3.9 P-04-522 Asbestos in Schools

The Committee considered correspondence from the Minister for Education and Skills and agreed to await a more substantive response from the petitioner.

3.10 P-04-603 Helping Babies Born at 22 Weeks to Survive

The Committee considered correspondence from the Chief Medical Officer and agreed, given the involvement of the petitioner in the development of updated guidance on the issue and that the petition has helped in ensuring that the very difficult and sensitive matters raised by the petitioner are being addressed, to close the petition.

3.11 P-04-456 Dementia - This Could Happen to you

The Committee considered correspondence from the petitioner and agreed to close the petition. In doing so, Members wished to convey their thanks for bringing the petition forward and to make the petitioner aware of the opportunity to bring forward another petition in the future should she wish to do so.

3.12 P-04-452 Equal Rights for Tube-fed Youngsters

The Committee considered correspondence from the petitioner and, given that they felt they could do no more to take the matter forward, agreed to close the petition. In doing so, Members wished to thank the petitioner for bringing the petition forward and helping them to understand the issues surrounding the petition.

3.13 P-04-424: Retain Services at Neath Port Talbot Hospital

3.14 P-04-624 That Foster Carers be Permitted to be Registered with More Than One Local Authority
