## **Presiding Officer Statement**

The Presiding Officer made a statement regarding language used in the chamber last week by the Leader of the UKIP group. Having reviewed the Record, the Presiding Officer stated that she had no doubt that Neil Hamilton AM had fallen foul of the Standing Orders that prohibit discourteous and unbecoming conduct and language that is disorderly, discriminatory, offensive, or which detracts from the dignity of the Assembly.
