Dear Russell,

The UK National Infrastructure Commission (NIC) is liaising with the Welsh Government on arrangements for engaging with stakeholders in Wales in order to help inform the commission's first National Infrastructure Assessment.

The importance of Wales' relationship with NIC has been emphasised during the consultation process for setting up our own infrastructure commission, with the EIS Committee underlining the value in its consultation response following your inquiry.

NIC would like to come to Wales to engage directly with stakeholders, suggesting a day's visit focusing on two roundtable sessions; the morning a session for politicians and the afternoon focusing on business and industry representatives.

Based on its experience of engagement to date, NIC advises that a maximum of around 40 attendees at each session works best.

I am happy with the outline arrangements for the visit, with a provisional date and location of 17 March in Wrexham, and am planning to chair the 'political' roundtable, to which I intend inviting all 22 Council Leaders.

I would welcome your views on which AMs to invite to this roundtable. Reflecting the remit of NIC, it might be most productive to invite members of the EIS Committee, the Cross Party Group on Cross Border Issues and the Cross Party Group on Sustainable Energy.

It would be very helpful to have your views by this Friday the 10th.
