 - Further consideration of whether the provision in Schedule 2, paragraph 3, subsub-paragraph (b), is sufficient to cover incidences whether a landlord/agency breaches this agreement, in particular in instances when students secure properties months before they move into the property and the agreement is pending further works by the landlord.
 - Further consideration as to whether fines issued by the Courts given to those in breach of the Bill should go to local authorities, as with fixed penalty notices.
