The Local Health Board and other stakeholders accept the need to develop and expand Primary and Community Health Services in and on behalf of the population of Flint.

Our Primary Care Estates Strategy outlined the need to take a holistic view of primary and community services, which include the Community Hospital. We did undertake a consultation exercise on our proposals which have been held in abeyance pending the conclusion of a number of reviews put in place by the Minister for Health. Thank you for your letter of 14th March on behalf of the Petitions Committee in relation to Petition P-03-085 Surgeries in Flintshire.

I am committed to ensuring that all buildings providing general medical services are fit for purpose for the 21st Century.

Flintshire Local Health Board (LHB) undertook a consultation on their proposals for primary care in Flint. The priority of schemes is a matter for Local Health Boards taking into account services across their area, the condition of current facilities and other factors. The LHB's Primary Care Estate Strategy may provide further information for you on the LHB prioritisation process.

I am aware of public disquiet and on Wednesday 17th October I announced in Plenary that four reviews would be undertaken on the reconfiguration of health services in N Wales.

The report undertaken by Dr Christopher Jones "A review of the impacts of developments in primary care and community care in relation to Designed for North Wales" was debated in Plenary on Wednesday 5th March. This was essential in considering the best way forward to provide services closer to the local community and avoid duplication of services.

I agreed with Dr Jones' suggestions for Flint Community Hospital, as outlined in the report and have requested that the LHB work with all local stakeholders and key decision makers. Under consideration will also be the possibility of a Primary Care Resource Centre being developed on adjacent land, which would include the three GP surgeries in Flint who submitted the petition.

Thank you for your letter of 3rd February asking about progress on the viability of a Primary Care Resource Centre being developed on land adjacent to Flint Community Hospital.

Flintshire Local Health Board (LHB) has established a Project Steering Group made up of the LHB, Trust, County Council and Community Health Council. The Group agreed Terms of Reference, met twice and established a Project Team to undertake the detailed work.

Before the Project Team could begin work in earnest the NHS in North Wales resolved to review 'Designed for North Wales' with a view to preparing and agreeing a new clinical futures strategy for the region. This new strategy would seek to explain more clearly the balance of care between secondary, community and primary care. Given the importance of first establishing this strategic and planning context the local planning of Flint services has been put on hold.

The planning timeframe for developing the new North Wales clinical futures strategy will allow the Flint Project Steering Group to recommence local planning in May.
