**Lesley Griffiths:** Wales Air Ambulance is expanding its emergency service in mid Wales from five to seven days a week. The Welsh Government supports the work of the Wales Air Ambulance charitable trust by providing central funding to cover the cost of its paramedics.

**The Minister for Health and Social Services (Lesley Griffiths):** Discussions have taken place between Welsh Government officials, including the chief medical officer, local health boards and higher education institutions regarding future medical education in Wales. A review of non-medical healthcare education provision has been undertaken. A multi-stakeholder group is in place leading strategic education and development for NHS Wales.

Healthcare organisations are currently being consulted on a comprehensive framework of actions to ensure that they have sustainable infection prevention and control arrangements in place for 2011-12 and beyond.
