**The Minister for Housing, Regeneration and Heritage (Huw Lewis):** I recognise the difficulties that first-time buyers experience raising a mortgage and I am actively considering options to support first-time buyers such as indemnifying mortgages, which would avoid the need for prohibitively large deposits. The Welsh Government also continues to support the homebuy scheme in Wales.
