- “It took 6 mths for my gate and fence to be fixed after a lorry knocked down”
- “Cracks and tripping hazards on my slab”
- “Roof in the utility block damp with mould growing”
- “Floor in the utility block uneven and washing machine moves across the floor because of this”
- “Doors never finished off”
- “Utility block has not been updated or painted ever”





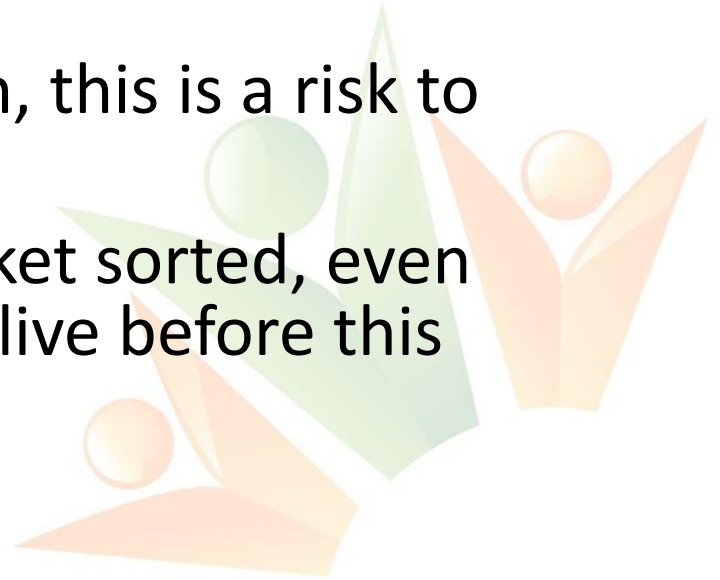
- “Walls just built on concrete not safe and could fall and hurt someone”
- “Because I have the same place as my family lived I can not get my wet room redone or fixed”
- “6 years of No hot water in my Utility block this was not fixed when I moved in”
- “Window cracked when I moved in and just covered with a board 5 years and more”
- “Mould and Mushrooms in the shed because of the damp conditions”
- “Shower not working and when I told the council they said it was a newish shower so they will not fix it”
- “I SHOULDN’T HAVE TO MOVE TO A HOUSE TO GET A BETTER STANDARD OF LIVING”



Three different broken windows, fixed with board



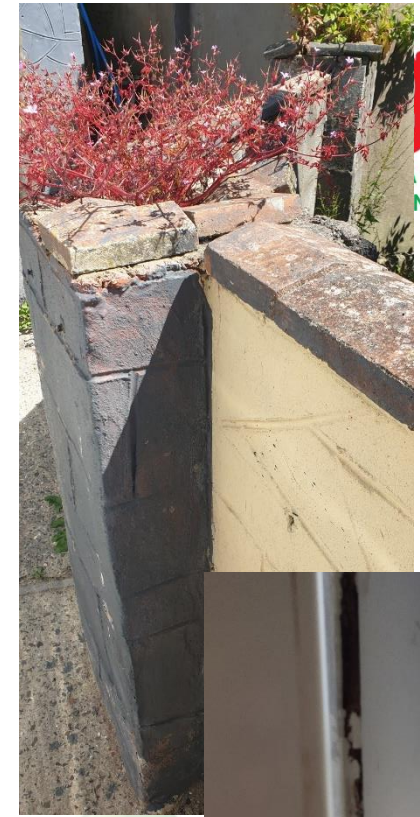
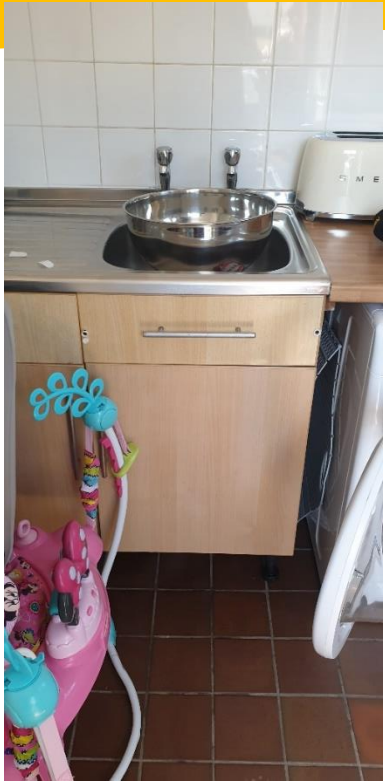
- “Fences need replacing they are broken and made of wood if there was a fire the whole place would go up”
- My tiles are falling off the wall reported this loads of times, nothing ever gets done. There was a leak the place is damp and black mould grows every where”
- “It has never been painted, Houses get painted we get ignored”
- “Fire hose removed, roads are too over crowded for fire trucks we would lose everything”
- “Quarry wall Falling down like a land slide in the rain, this is a risk to my family and my property”
- “It has taken 2 years to get my light and electric socket sorted, even then they just cut the wires and left it. The box was live before this thank goodness no one had a shock”





- “Vent is broken said a few years ago they will be back the next day to fix it, they never did”
- “My shed is damp and water just drips off the tiles”
- “Blocked drains My Husband cleaned it, we ring and ring but no one ever comes out”
- “My roof has been leaking for 8/9 years when it was fixed it was never finished and they chipped my bath so now I can’t use the bath”
- “ we had to pay for our own fencing”
- “Drains covers are broken, uneven and trip hazards, lights on the site don’t all work so dark and dangerous to walk around at night as the floor is so uneven. I even have a water pipe with a bulldog clip leaking water and left just sticking up in my garden. My daughter will be walking soon and I am very worried that she is going to injure herself, I have told the council they told me it will cost too much to fix it”





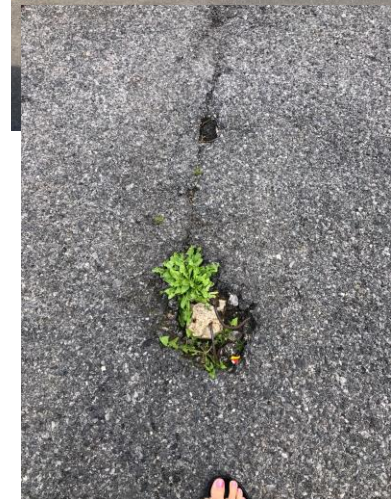
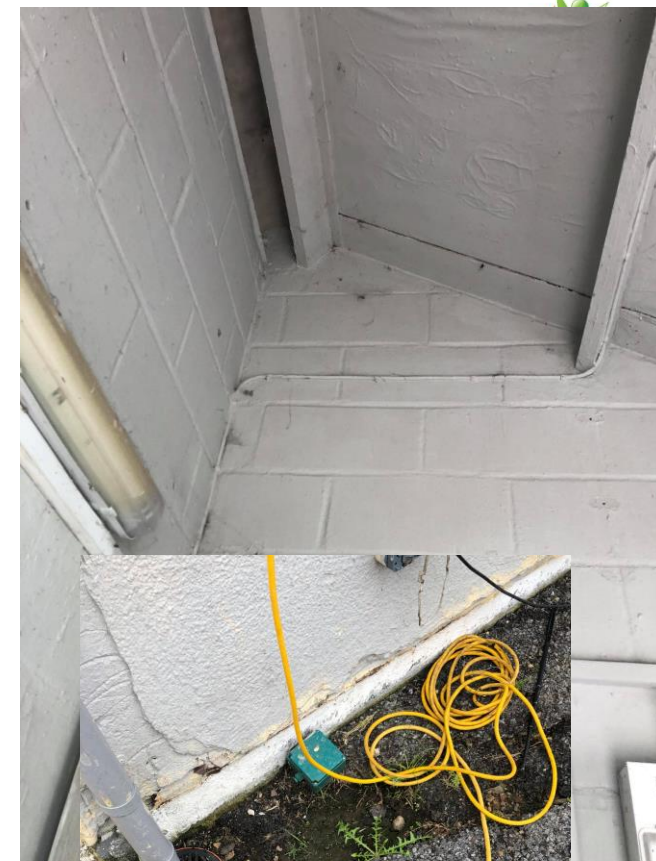
- “My Utility block has no storage, cupboards have been screwed together, there is no room for a cooker, it is damp and paint is falling off the ceiling, the floor floods everyday so I cant store anything in it the council can not find where the leak is, I only live in a caravan, my babys toys have to stored in there including high chair and bouncer, I have to clean the mildew off them daily. Heater not working but even if it was it is too expensive to run, my floor is uneven so when it floods it floods in pools. I asked the council to fix my bath panel they came with a small piece of wood to just fix the hole, I want to live in a place that is not just quickly fixed, if it was fixed properly in the first place they wouldn't have to do it again. I asked when I moved in if I could have my utility block painted they said that was my job, I also asked if I could have my worktops fixed as they were hanging off the wall, they had been there as long as I known, I was also told that they would not do this”



- “My Slab is so small that I can not even park my car on my own Slab”
- “3 Slabs are being condemned, I asked if I could have a bit of one as I have not even enough room to use my utility block. I have three children and can only have a two bedroom trailer on the property as there is no space, I need to have more room you can see by the pictures that there is no space. If there was a fire everything will go up in flames”
- “ My Mums home was so close to the neighbours place that when she was dying the hospital would not allow her home as she needed oxygen, the hospital said it was a fire hazard. My mum died in hospital and not at home where she belonged”

These statements were said over and over again to me, no lights, tripping hazards, fences broken, cracks, tripping hazards, mould, damp, floods, never been updated, sockets not working, heaters not working and very expensive. No point in ringing the council as nothing ever gets done.





- “I Can not get a bigger trailer because there is a telephone pole on my slab, I have asked for it to be moved but they want to charge me for it”
- “sewage flowing on to my slab, Denise had to sort it for me. When I asked they said it was not an emergency”
- Rats pulling my bins apart, crawling over my water tank and walking around in the day time”
