**The Minister for Health and Social Services (Mark Drakeford):** The cancer delivery plan published in July 2012 sets out the Government's strategic policies for NHS cancer services to 2016. Local health boards have developed local cancer plans and are best placed to determine the location of services to deliver safe sustainable services for their populations.

**Mark Drakeford:** Nid oes cynlluniau ar hyn o bryd i adolygu'r gwasanaethau prothetic brys. Mae tair canolfan aelodau artiffisial a chyfarpar sy'n darparu gwasanaeth prothetic, ac mae un o'r rhain yn Wrecsam. Er nad ydynt yn cynnig gwasanaeth argyfwng ddydd a nos, maent yn gallu ymateb yn gyflym i broblemau brys.

**Mark Drakeford:** There are no current plans for a review of emergency prosthetics services. There are three Artificial Limbs and Appliances Centres, including one in Wrexham, which provide prosthetic services. While they do not provide an emergency 24/7 service, they are able to respond promptly to urgent problems.

Yn ystod y broses cafwyd cysylltiad agos â chlinigwyr diabetes pediatrig, a hefyd â phobl ifanc sydd â diabetes math 1. Bydd y cynllun cyflawni terfynol yn cael ei gyhoeddi yn ystod yr haf. Bydd y cynllun hwn yn nodi strategaeth y Llywodraeth ar gyfer gwella'r gofal i blant sydd â diabetes, gan wneud yn siŵr bod anghenion y plentyn yn ganolog i'r gwasanaeth.

**Mark Drakeford:** The recently concluded consultation on a draft diabetes delivery plan included active engagement with paediatric diabetes clinicians and young people with type 1 diabetes. A final plan will be published in the summer. This plan will set out the Government's strategy for improving the care of children with diabetes, putting the needs of the child at the heart of service delivery.
