The Minister for Housing and Regeneration (Carl Sargeant): The process for handling called-in applications is administered by the Planning Inspectorate. An application may proceed by way of written representations, a hearing or public inquiry. An independent planning inspector is appointed to consider an application and prepare a report with recommendations, with the final decision taken by Ministers.

Carl Sargeant: I am concerned about the prospect of increased arrears from UK policies such as bedroom tax. It is too early to say what the impacts will be but a pilot project in Torfaen suggests that there could be considerable increase. Rent arrears can lead to eviction and homelessness, and can threaten the financial viability of housing associations.

Carl Sargeant: Our 10-year homelessness plan sets out the direction that we are taking and focuses on prevention. We are implementing it through funding, guidance, research and legislation. In the autumn, I will bring forward specific proposals to strengthen homelessness legislation in my housing Bill.
