Older People

The Deputy Minister for Children and Social Services (Gwenda Thomas): I am committed to ensuring that older people receive high-quality care and support, to maintain independence in their home or community. A key priority is preventing unnecessary hospital admissions and delayed discharges. This requires close working between health and social services and with housing, third sector and independent partners.

The Minister for Health and Social Services (Mark Drakeford): Uptake figures for MMR vaccination continue to show a positive trend. Data published by Public Health Wales for the second quarter of 2013, between April and June, indicate that average uptake across Wales has continued to show improvement for all age groups compared with the first quarter.
