During plenary on 9 December, you asked me if any trends were emerging in relation to the provision of private Gypsy and Traveller sites. I have now reviewed the Caravan Count data which is collected on a biannual basis and can provide you with the following information.

The table in Appendix A shows the number of authorised sites across Wales has more than doubled since the Caravan Count was restarted in 2007. Of the 65 authorised sites recorded at the last Count in July 2015, 23 were recorded as Local Authority sites (including the temporary site for the Royal Welsh Show and Waterloo in Pembrokeshire). At the time of the first Count in 2007, 20 of the 31 recorded sites were Local Authority owned (however, the Leighton Arches / Withybeds site was not recorded, which would have meant 21 of 32 sites were Local Authority owned). Therefore, private Gypsy and Traveller provision has effectively risen from 11 sites in 2007 to 42 sites in 2015.

However, whilst this progress is welcomed we know a significant shortfall in Gypsy and Traveller site provision remains. I expect all Welsh Local Authorities to submit new Gypsy and Traveller Accommodation Assessments (GTAAs) to me by 26 February 2016, which will capture the most comprehensive Wales-wide estimate of pitch need we've ever had.

Under the Housing (Wales) Act 2014, Local Authorities will be required to ensure site provision is made to meet the needs identified in GTAAs. Crucially, the duty is for Local Authorities to exercise their powers as far as may be necessary to ensure sites are created, which provides Local Authorities with the flexibility to work with households who may wish to develop private sites.

I am aware many Gypsy and Traveller households would rather live on small family sites and I would encourage Local Authorities to support the development of such viable private sites, which would reduce the overall level of need in the area and have the added benefit of reducing costs to the public purse.


