- (1) Within 12 months of the day on which this Act receives Royal Assent, the Welsh Ministers must establish –
- (a) an Oversight Project Board ("Board"), and
 - (b) an Advisory Panel for single-use plastic products ("Panel"), for the purposes listed in subsections (2) and (3) and to carry out the functions set by the Welsh Ministers in accordance with subsection (4).
- (2) The purpose of the Board is to enable –
- (a) accountability of the Welsh Ministers in relation to this Act,
 - (b) oversight of the delivery of this Act, and
 - (c) evaluation of the implementation of this Act and regulations made under this Act.
- (3) The purpose of the Panel is to provide advice to the Welsh Ministers, and if requested by the Welsh Ministers, to the Board, on matters connected with this Act.
- (4) The functions of the Board and the Panel are such functions as the Welsh Ministers may set.
- (5) The functions which the Welsh Ministers set the Board may include –
- (a) regular progress review of policy and legislative proposals,
 - (b) monitoring product-specific projects,
 - (c) reviewing milestones, and
 - (d) considering appropriate mechanisms to collaborate with and involve stakeholders in developing and delivering proposals.
- (6) The functions which the Welsh Ministers set the Panel may include providing advice on –
- (a) matters relating to the affordability of reusable products that may replace prohibited single-use plastic products,
 - (b) steps that can be taken to make reusable products more affordable than prohibited single-use plastic products they may replace,
 - (c) how prohibition of single-use plastic products can be included within a curriculum designed in accordance with the Curriculum and Assessment (Wales) Act 2021,
 - (d) raising public awareness of this Act, and
 - (e) public engagement related to this Act.'
