#### Dr Liz Marks

- Paper published in the Lancet looking at climate anxiety across 10 countries around the world
- Looking at how this is linked to government inaction and a feeling of betrayal by the government
- This can lead to moral injury which can lead to mental inhealth
- Governments' inactions on climate change and fossil fuels can have implications for human rights
- Have been holding workshops with 6<sup>th</sup> formers giving them a space to echo emotions and give a sense of hope and use them as a catalyst for action
- Links to work being done with Bath Beacons looking at living well and researching how nature links to eco anxiety as well as how nature based therapies may be helpful e.g. wild swimming
- Working with the British Psychological Society to integrate planetary health into how clinical psychologists think

 What would it take to make the future desirable, assuming global warming is happening and we can't opt out?

 We need to have realistic hope linked to an understanding of what we value, so a meaning focused approach

#### Kim Mamhende

- The language used to discuss climate change can be quite off putting, it can seem like a big subject which can be difficult to navigate
- It's harder to reach people from disadvantaged backgrounds who are most likely to be affected by climate change
- Often the language isn't relatable

- On the ground action can be unattractive as people may have trauma from police violence and hostility and there are disproportionate arrests on people of colour
- Climate action is often perceived as a white middle class movement but we need to empower more affected communities to take action and increase representation
- Climate change is also a social justice and class issue
