	the session and handed over to our presenter.
White Paper on	Presentation
Ending	Debbie Thomas
Homelessness in	Head of Policy and Communications (Wales), Crisis
Wales	The presentation focussed on how legal change could help end homelessness.
Discussion Space	Cllr Lynda Thorne – welcomed the White paper but expressed concern over local
	authorities capacity to deliver extra requirements while there is such a shortfall in

housing supply. While there has been much focus on legislative reform, housing supply is needed to enable real change. **Damien from the Disability Housing Task Force** – please come along to the Disability Rights Task Force and ensure that voices from people with complex needs are being heard. **Carolyn Thomas** – would like to hear the panel's recommendations on how to abolish priority need and intentionality and how would it work. Priority need is a massive barrier to many who have significant housing need. The consequences of intentionality are currently very severe and punitive. **Elizabeth Taylor** – Does the White Paper address the home ownership sector? **Huw Irranca-Davies** – Local Authorities are struggling to make reasonable offers due to lack of options/supply. The benefits system isn't devolved to Welsh Government so there were limitations on what recommendations the panel could make. Crisis recently worked with Zoopla to gather data that shows how few properties are available across Wales to rent at LHA rates. They are writing to Jeremy Hunt about this. The White Paper has adopted that Personal Housing Plans should be a statutory duty, looking at individuals needs. This should go a long way to ensuring that suitable offers are made to that person. **Linda Davies Evans** – there will be more refusals of offers without local connection. It is understandable why someone would refuse an offer that is outside their local community. People are losing their community and support network when they need them most, at a time when they are already losing their home. There is a serious shortage of properties in Carmarthenshire. **Debbie Thomas** – local connection was a very difficult area for the panel. Local connection has been softened but not abolished. . It can now be more sensitive to those at heightened risks (e.g. care leavers etc) but can take on board other types pf connection to an area. Carolyn Johnstone – Interested in views about the Home Offices comments relating to tents. Group members agreed that Suella Braverman should be held to account. Mabon could raise the issue at the Senedd as chair of this group, but it must be at the members request. AGM The AGM was not held due to lack of representation Cymdeithas yr Iaith Conference – Mabon ap Gwynfor informed everyone of the **AOB** conference which will focus on the Right to Adequate Housing and will be held 16th November at the Pier Head Building, Cardiff Bay. Close of Meeting Mabon ap Gwynfor MS thanked attendees and speakers.
