## **Agenda, Notes & Actions**

## 1. Welcome, Introduction and Apologies

The Chair thanked all members of the CPG for their commitment to the discussions over the last 12 months, noting and thanking the attendance and contribution from Ministers.

The Chair noted his continued support for the CPG but due to capacity and other commitments that he would be stepping down as Chair but very happy to continue to be involved.

## 2. Nominations for Chair, Vice Chair(s) and Secretariat

The Chair handed over to the Secretariat to call for nominations for the position of Chair by any of the Members of the Senedd (MS) in the meeting. HI-D nominated SR; CC seconded the nomination (by proxy in email correspondence). SR accepted the position and PD handed back the to the new Chair.

The Chair called for nominations for the position(s) of Vice Chair. SR nominated HI-D & CC; CC & HI-D seconded each other respectively. Both CC & HI-D accepted the positions of Vice Chair.

PD offered a willingness to continue in the role of Secretariat with the support of Rebecca Brough. This was supported by all in attendance at the meeting.

#### Meeting #2 13.12.2021

What & who is the Outdoor Sector presentation followed by informal discussion

Meeting attended by Vaughan Gething, Minister for Economy

#### **Action Points**

**AP1:** A letter to be sent to cross cabinet members of the government and the First Minister, picking up on key points - challenges, opportunities and solutions to the issues in question and noting that we are keen to work with and help WG. **Secretariat to start this process, utilising the Outdoor Alliance Manifesto 2021 as a starting point for identifying the key points. All to contribute thereafter.** 

AP2: A back bench debate in the Spring to raise the profile of the sector and some of the points raised today. All to consider the key aspects that need to be included in the debate and reach out to respective MSs (the content of the letter noted in Action 1. will assist with this). Chair & Vice Chair to identify an opportune time for this to happen and therefore make it happen.

**AP3:** Update economic and social value research for the outdoor sector in Wales and consider updating the research related to the economic value of the rights of way networks across Wales. **Secretariat to collate any existing research as a staring point. All to contribute.** 

#### Meeting #3 12.07.2022

Why equitable Access to the outdoors is needed presentation followed by informal discussion Meeting attended by Julie James, Minister for Climate Change

#### **Action Points**

**AP1:** Letter to be drafted from the Chair to put formal proposals on a public land pilot to the Minister.

**AP2:** Add to agenda for next meeting consideration of funding resources to explore what can be progress now and agree a way forward.

Meeting #4 28.09.2022

**Outdoor Education & Learning in Wales** presentation followed by informal discussion Meeting attended by Jeremy Miles, Minister for Education & Welsh Language

#### **Action Points**

AP1. Mapping exercise of resources to be explored with the OEAP - Secretariat to initiate conversations with key outdoor education organisations and report back at the next meeting of the CPG.

**AP2.** Further explore Minister suggestion of National Network conversations with a focus on Outdoor Learning - **Secretariat to make a request of the Minister to make a visit of Storey Arms in the new year with a view to following up on the Ministers suggestion and also his other reflections.** 

AP3. Arrange an AGM - Secretariat to make the necessary arrangements asap, ensuring the availability of the Chair and Vice Chairs.

## 5. Ideas for future meeting topics

The Chair opened this request out initially to the Secretariat for any initial thoughts before opening it up to the members in attendance.

The Secretariat noted that initial and informal invitations have been made to Dawn Bowden Deputy Minister for Sport to join the next CPG meeting early in the near year where the focus will be around Safety in the Outdoors, taking into account the following: The Adventure Activities Licensing Authority (AALA) ongoing review and the proposed sector-led alternative to AALA, were the act to be repealed in Westminster; The safety of the people of wales and those who visit Wales whilst venturing outdoors. It was agreed that a formal approach would be made by the CPG to the Deputy Minister, with the support of HI-D to attend a face to face extended meeting early in 2023 at Plas Menai to include two presentations, each followed by discussions and with the opportunity (weather & time of year permitting) to take part in an outdoor activity (thanks to Plas Menai for offering their venue and activity opportunity).

The following is an overview of the suggestions made during the meeting:

- Access a follow up to the previous meeting held in July 2022, possibly involving representatives from the WLGA;
- ii. Access to water whilst related to the above, it was felt that there was merit to have specific discussion relating to access to water;
- iii. Social Prescribing with the possibility of inviting the Minister for Health to join us;
- iv. Outdoor & Adventure Tourism possibly use the Covid situation as a catalyst to consider the impact on communities etc. - education regarding how to sustainably use the natural environment;
- v. Consider inviting other key individuals to attend and present at meetings, those who are in positions of influence

All suggestions were well received by all.

The following are topics highlighted during the inaugural meeting of the CPG which are yet to have been discussed:

- vi. The strengths of being outdoors and how to connect with nature;
- vii. Making use of the outdoors for health and well-being benefits;

viii. Workforce development and developing pathways for employment - apprenticeships.

## 6. Summary of Actions

AP1. Formally invite Dawn Bowden Deputy Minister for Sport to join the CPG for a face to face meeting at Plas Menai, early in 2023. HI-D (Vice Chair) to make this formal invitation on behalf of the CPG. Secretariat to liaise with Plas Menai and invite all CPG members once a date has been confirmed.

AP2. Chair & Secretariat to liaise regarding plans for the next 12 months.
