Dear Jenny,

Thank you for your letter of 18 March to the then Deputy Minister for Social Partnership posing further questions relating to the Committee's current inquiry into Fire and Rescue Authority (FRA) governance. Fire matters now fall within my portfolio, and my responses are as follows.

Reviews in North Wales and Mid and West Wales FRAs

Your letter refers to the then Deputy Minister's written statement of 11 March, when she noted that allegations of staff misconduct in North Wales and Mid and West Wales had been made; and that in light of those allegations, independent reviews of those organisations were merited. You also quote the Chief Fire Officer (CFO) of Mid and West Wales, and the Chair of North Wales FRA, who welcomed these developments and the scrutiny that the reviews will provide.

I do not think there is any conflict between these statements. All agree (as do I) that it is important to have full assurance about workplace cultures and management practices in both organisations. Individual acts of misconduct, while wholly deplorable, do not of themselves establish that the situation is as it was in South Wales, where the workplace culture was oppressive and discriminatory, and management processes were dysfunctional. An independent review is the best way of doing this.

NWFRA and MWWFRA will commission and oversee the reviews, and your detailed questions about appointments, timings and terms of reference should be addressed to them. I expect only that the reviews will be headed by someone of suitable standing from

outside the Fire and Rescue Service, that they will engage openly and extensively with current and former staff, and that they will report as soon as possible.

Inspection and audit

I addressed most of the issues you raised in your letter in my evidence paper to the Committee, and have little to add to that.

The only recent change to the inspection regime in England of which I am aware is the move last year from a four-point scale of graded judgements (outstanding / good / requires improvement / inadequate) to a five-point one (which has an "adequate" grade between "good" and "requires improvement"). I do not think that materially changes the overall regime or its strengths and weaknesses. As I said in my evidence paper, there are pros and cons for that approach, but one cannot expect it always to detect or prevent management and cultural failings – as indeed it has not in England.

Chief Fire and Rescue Advisor

The Chief Fire and Rescue Advisor (CFRA) was appointed by the Queen under s28 of the Fire and Rescue Services Act 2004 to inquire into how FRAs are exercising their functions; and to advise the Welsh Government and FRAs accordingly. As a former CFO, his primary focus is rightly on operational matters, which form his main area of expertise. However, that does not preclude him from inquiring into matters of organisational culture and management, especially because these can all too easily affect operational performance. The current CFRA has therefore been very closely involved in decision-making around the South Wales intervention, and about the position elsewhere in Wales.

The CFRA is also a permanent Welsh Government civil servant. It would not be normal or appropriate for civil servants to meet political appointees like FRA Chairs on their own account; that is the role of Ministers. Accordingly, and in line with his status as a professional advisor on operational matters, the CFRA deals mostly with the CFOs and other FRS staff.

You also ask about the former Deputy Minister's meetings with FRA Chairs over the past three years. There were 21 such meetings, which I have set out in the annex to this letter. The CFRA and/or other Welsh Government officials attended all of these meetings to support her; they also meet the CFOs every three weeks, and the CFOs and other FRS staff frequently in other forums and *ad hoc*. I cannot agree with the views of Cllr Bradwick which you quote in your letter, that engagement was inadequate.

HMICFRS recommendations

You asked about the former Deputy Minister's correspondence with the FRAs following the report from His Majesty's Inspectorate of Constabulary and Fire and Rescue Services of March 2023 about the culture of FRSs in England. This is attached, in the form of the letter to the CFO of North Wales FRS (the others were substantially identical), along with the replies received. Please note that these documents exist only in English, reflecting the CFOs' language preferences.

Training of FRA Members

Training and induction of FRA Members is a matter for the FRA concerned; the WLGA may also be able to offer support in this area. I cannot comment on the content of such training.

Social Partnership Forum

The former Deputy Minister established the Social Partnership Forum for Fire and Rescue Services in January 2023, and chaired all its meetings. The membership includes:

- the three FRA Chairs (for SWFRA, now one of the Commissioners rather than the Chair)
- all recognised trade unions and representative bodies in the sector (Fire Brigades Union, Fire and Rescue Services Association, Fire Officers Association, Fire Leaders Association, GMB, UNISON and Unite)
- the WLGA
- the Welsh Government (in the form of the CFRA)

The CFOs and other officials attend in an advisory capacity, but are not full members of the Forum.

I am happy to share agendas and minutes of the Forum. I have attached agreed minutes (which also reflect the agendas) for meetings up to October 2023, and the agenda for the meeting of 11 March 2024 (the minutes of which will be agreed at the next meeting). I will also arrange for future agendas and minutes to be passed to the Committee. Please note that these documents exist only in English, reflecting the language preferences of Forum members.
