‘() to ensure that –

- (i) it has at least one maintained primary school and at least one maintained secondary school in each language category (see section 9) in its area, or
- (ii) where for reasons to be set out by the local authority in its plan it is not possible for the local authority to comply with sub-paragraph (i), it has arrangements in place with neighbouring local authorities to facilitate access to education in each language category;’.
