Section 11, page 6, leave out lines 34 to 40 and insert –

- ‘() taking the accommodation portion of the transaction, and
- () multiplying that amount by the levy rate that applies in relation to the visitor accommodation (see section 12).
- () The “accommodation portion” means the amount payable under the contract for the overnight stay that is attributable to the provision of overnight accommodation.
- () But the accommodation portion does not include any amount reasonably attributable to the provision of –
 - (a) meals or drinks,
 - (b) parking for a motor vehicle (other than a parking area within the premises at which the visitor accommodation is provided),
 - (c) laundry facilities or services,
 - (d) entertainment, or
 - (e) transportation to or from the visitor accommodation.’.

Page 13, after line 24, insert a new section –

‘[] Levy partnership forums

- (1) A principal council that has introduced the visitor levy in its area must establish a forum (a “levy partnership forum”) for discussion of issues relating to the visitor levy in the council’s area, with a view to providing the council with, in particular –
 - (a) information and advice on how the proceeds of the levy may be used for the purposes of destination management and improvement in the council’s area;
 - (b) information and advice on a proposal by the council (where the Welsh Ministers have made regulations under section 14 enabling principal councils to add an additional amount to the levy) to –
 - (i) add an additional amount to the levy,
 - (ii) change an additional amount that has been added to the levy, or
 - (iii) remove an additional amount that has been added to the levy,whether before or after the council publishes a report under section 25(3)(b).
- (2) The principal council must, in the exercise of any functions under this Part, have regard to any information or advice provided in the forum on the matters specified in subsection (1)(a) and (b).
- (3) The principal council must –
 - (a) take reasonable steps to ensure that it has established the levy partnership forum no later than three months after the date on which the levy comes into effect in the council’s area,
 - (b) make arrangements for the forum to meet at least once in each financial year in which the levy has effect in the council’s area, and



- (c) facilitate meetings of the forum and take reasonable steps to ensure that the forum is able to effectively discuss issues, and provide information and advice, as described in subsection (1).
- (4) The principal council –
 - (a) must take reasonable steps to ensure that the levy partnership forum includes persons who are representatives of –
 - (i) organisations that represent businesses that work in tourism, or are engaged in activities related to tourism, in the principal council's area;
 - (ii) organisations that promote or facilitate tourism in the council's area;
 - (b) may include in the forum any other persons, that have an interest in tourism or visitor accommodation in the council's area, that the council considers appropriate.
- (5) The principal council must, in exercising its functions under subsection (3), take reasonable steps to ensure that the forum membership is representative of a range of views concerning tourism and visitor accommodation in the council's area.'.

 - (a) gwybodaeth a chyngor ynghylch sut y gellir defnyddio enillion yr ardoll at ddibenion rheoli a gwella cyrchfannau yn ardal y cyngor;
 - (b) gwybodaeth a chyngor ynghylch cynnig gan y cyngor (pan fo Gweinidogion Cymru wedi gwneud rheoliadau o dan adran 14 sy'n galluogi prif gynghorau i ychwanegu swm ychwanegol at yr ardoll) i –
 - (i) ychwanegu swm ychwanegol at yr ardoll,
 - (ii) newid swm ychwanegol sydd wedi ei ychwanegu at yr ardoll, neu
 - (iii) dileu swm ychwanegol sydd wedi ei ychwanegu at yr ardoll,pa un ai cyn neu ar ôl i'r cyngor gyhoeddi adroddiad o dan adran 25(3)(b).
- (2) Rhaid i'r prif gyngor, wrth arfer unrhyw swyddogaethau o dan y Rhan hon, roi sylw i unrhyw wybodaeth neu unrhyw gyngor a ddarperir yn y fforwm ar y materion a bennir yn is-adran (1)(a) a (b).
- (3) Rhaid i'r prif gyngor –
 - (a) cymryd camau rhesymol i sicrhau ei fod wedi sefydlu'r fforwm partneriaeth ardoll heb fod yn hwyrach na thri mis ar ôl y dyddiad y daw'r ardoll yn effeithiol yn ardal y cyngor,
 - (b) gwneud trefniadau i'r fforwm gyfarfod o leiaf unwaith ym mhob blwyddyn ariannol y mae'r ardoll yn cael effaith ynddi yn ardal y cyngor, ac
 - (c) hwyluso cyfarfodydd y fforwm a chymryd camau rhesymol i sicrhau bod y fforwm yn gallu, fel y disgrifir yn is-adran (1), drafod materion, a darparu gwybodaeth a chyngor, yn effeithiol.



(4) O ran y prif gyngor –

- (a) rhaid iddo gymryd camau rhesymol i sicrhau bod y fforwm partneriaeth ardoll yn cynnwys personau sy'n gynrychiolwyr o –
 - (i) sefydliadau sy'n cynrychioli busnesau sy'n gweithio ym maes twristiaeth, neu sy'n ymwneud â gweithgareddau sy'n gysylltiedig â thwristiaeth, yn ardal y prif gyngor;
 - (ii) sefydliadau sy'n hybu neu'n hwyluso twristiaeth yn ardal y cyngor;
 - (b) caiff gynnwys yn y fforwm unrhyw bersonau eraill, sydd â buddiant ym maes twristiaeth neu mewn llety ymwelwyr yn ardal y cyngor, y mae'r cyngor yn ystyried eu bod yn briodol.
- (5) Rhaid i'r prif gyngor, wrth arfer ei swyddogaethau o dan is-adran (3), gymryd camau rhesymol i sicrhau bod aelodaeth y fforwm yn gynrychioliadol o ystod o safbwyntiau sy'n ymwneud â thwristiaeth a llety ymwelwyr yn ardal y cyngor.'.

- (a) an estimate of the proceeds of the levy in respect of the first full financial year after the levy is introduced and an estimate of the costs the principal council is likely to incur in connection with the proposal,
 - (b) information on how the principal council intends to use those proceeds and on how that use will be for the purposes of destination management and improvement in the council's area, and



- (c) the principal council's proposals for membership of the levy partnership forum to be established by the council under section [section inserted by amendment 153], specifying the persons the council intends to invite to be members of the forum.'
