[] Where primary legislation (within the meaning given by section 4(5)) confers a power that is exercisable in relation to enactments (or enactments of a particular description) that were enacted or made before a particular time or event, the power is also exercisable in relation to any provision re-enacting such an enactment that is –

- (a) contained in the principal Act, or
- (b) inserted into any other enactment by this Act.’

‘Duration of local development plans

- [] (1) In section 19 of the principal Act, subsections (5), (6) and (9) do not apply to a local development plan that was adopted before 4 January 2016 (the day on which section 12 of the Planning (Wales) Act 2015 (anaw 4) came fully into force).
- (2) In section 326(5)(a)(i) of the principal Act, the reference to the end of the period specified in a relevant development plan is to be read, in relation to a plan that was adopted before 4 January 2016, as a reference to the end of a period of 15 years from the date of the counter-notice.’.
