**Title**

**1.** The title of this Order is the Local Government Finance (Wales) Act 2024 (Commencement No. 1) Order 2026.

**Provision coming into force on 1 April 2026**

**2.** Section 18 (discounts) of the Local Government Finance (Wales) Act 2024 comes into force on 1 April 2026, in so far as the section is not already in force.
