Page 3, after line 8, insert a new section –

[] **Report on the development of tourism in Wales**

- (1) The Welsh Ministers must prepare and publish a report setting out the steps the Welsh Ministers have taken, or intend to take, to promote the development of tourism in Wales.
- (2) The Welsh Ministers must –
 - (a) publish a report under subsection (1) by no later than 1 April 2027, and
 - (b) lay the report before Senedd Cymru.
- (3) A report published under this section must include an assessment of –
 - (a) the impact of the requirements specified in section 66(2BB)(d) of the Local Government Finance Act 1988 on providers of self-contained self-catering accommodation in Wales, and
 - (b) alternative minimum letting periods to those specified in that provision.’.

- (1) Rhaid i Weinidogion Cymru lunio a chyhoeddi adroddiad sy’n nodi’r camau y mae Gweinidogion Cymru wedi eu cymryd, neu’n bwriadu eu cymryd, i hybu datblygiad twristiaeth yng Nghymru.
- (2) Rhaid i Weinidogion Cymru –
 - (a) cyhoeddi adroddiad o dan is-adran (1) heb fod yn hwyrach na 1 Ebrill 2027, a
 - (b) gosod yr adroddiad gerbron Senedd Cymru.
- (3) Rhaid i adroddiad a gyhoeddir o dan yr adran hon gynnwys asesiad o –

- (a) effaith y gofynion a bennir yn adran 66(2BB)(d) o Ddeddf Cyllid Llywodraeth Leol 1988 ar ddarparwyr llety hunanddarpar hunangynhwysol yng Nghymru, a
- (b) cyfnodau gosod eiddo gofynnol amgen i'r rhai a bennir yn y ddarpariaeth honno'.

Section 60, page 38, leave out lines 11 to 12 and insert –

- '() The following provisions of this Act come into force on the day after the day on which this Act receives Royal Assent –
 - (a) this Chapter, other than section 55 (guidance), and
 - (b) section [*section to be inserted by amendment x (Report on the development of tourism in Wales)*].'

Section 60, page 38, line 14, leave out 'except that –

- (a) sections 16, 24, 25(2) and (3), 27, 37 and 38, come into force on 5 March 2029 if they have not come into force before that day, and
 - (b) the remaining provisions of this Act come into force on 4 March 2030 if they have not come into force before that day.
- (3) The Welsh Ministers may by order made by Welsh statutory instrument amend the date referred to in subsection (2)(b) to a day that is no later than 2 years after that day' and insert –
'subject to the Senedd approval procedure'.

- (3) Caiff Gweinidogion Cymru drwy orchymyn a wneir drwy offeryn statudol Cymreig ddiwygio'r dyddiad y cyfeirir ato yn is-adran (2)(b) i ddiwrnod nad yw'n hwyrach na 2 flynedd ar ôl y diwrnod hwnnw' a mewnosoder –
'yn ddarostyngedig i weithdrefn gymeradwyo'r Senedd'.
