- ‘() is an owner, co-owner or trainer of a greyhound and uses such greyhound, or knowingly permits such greyhound to be used, for greyhound racing in Wales, or
- () is an attendee of greyhound racing in Wales.’.

‘Review of Act

[] Review of operation and effect of Act

- (1) The Welsh Ministers must, no later than the end of the 5 year period, carry out a review of the operation and effect of this Act.



- (2) In this section, “the 5 year period” means the period of 5 years beginning with the day appointed by the Welsh Ministers under section 5(2).’.

[] Report on operation and effect of Act

- (1) The Welsh Ministers must, as soon as practicable after the end of the 5 year period, lay before Senedd Cymru a report on the operation and effect of this Act during that period.
- (2) In preparing the report the Welsh Ministers must consult such persons as they consider appropriate.
- (3) The Welsh Ministers must publish the report as soon as practicable after it has been laid before Senedd Cymru.
- (4) “The 5 year period” is the period of time specified in section [new section to be inserted by amendment 6](2).’.

‘Transitional arrangements

[] Interim regulation of greyhound racing



- (1) The Welsh Ministers must make regulations to provide for the regulation of greyhound racing in Wales.
- (2) Regulations under this section must provide for the regulation of greyhound racing in Wales to come into force within six months of this Act receiving Royal Assent.
- (3) The regulations must provide for the regulation of greyhound racing in Wales until the date appointed by the Welsh Ministers under section 5(2).
- (4) The power to make regulations under this section is exercisable by Welsh statutory instrument.
- (5) Regulations made under this section are subject to the Senedd approval procedure.’.

‘Review of transitional arrangements

[] Review of interim regulation of greyhound racing

- (1) The Welsh Ministers must –
 - (a) undertake a review of the effectiveness of the regulation of greyhound racing in Wales,
 - (b) publish, in such manner as they consider appropriate, a report of the review, and
 - (c) lay the report before Senedd Cymru.
- (2) The review under subsection (1) must be completed within 2 years of the regulations under section [section to be inserted by amendment 12] coming into force.
- (3) A report under this section must be published and laid before Senedd Cymru at least 3 months before the Welsh Ministers appoint a day under section 5(2).’.

‘Economic and social impact of Act

[] Assessment of economic and social impact of Act

- (1) The Welsh Ministers must assess the economic and social impact of prohibiting greyhound racing in Wales.
- (2) The assessment must, in particular, consider –
 - (a) the economic impact on those directly and indirectly employed in greyhound racing and associated industries in Wales;
 - (b) the impact on local economies and communities in which greyhound racing currently takes place;
 - (c) the consequences for animal welfare arising from the displacement or cessation of regulated greyhound racing;
 - (d) the potential costs to the public sector arising from enforcement, rehoming, or welfare interventions;
 - (e) any other matters identified as relevant in the report of the Senedd’s Culture, Communications, Welsh Language, Sport, and International Relations Committee on greyhound racing laid before Senedd Cymru on 5 December 2025.
- (3) In carrying out the assessment, the Welsh Ministers must consult –
 - (a) persons involved in the greyhound racing industry;
 - (b) local authorities affected by a prohibition;
 - (c) animal welfare organisations;
 - (d) such other persons as the Welsh Ministers consider appropriate.
- (4) The Welsh Ministers must –
 - (a) publish, in such manner as they consider appropriate, a report of the assessment, and
 - (b) lay the report before Senedd Cymru.



- (5) The assessment must be completed and a report of the assessment laid before Senedd Cymru at least 3 months before the Welsh Ministers appoint a day under section 5(2).’.

- (a) yr effaith economaidd ar y rhai a gyflogir yn uniongyrchol ac yn anuniongyrchol mewn rasio milgwn a diwydiannau cysylltiedig yng Nghymru;
 - (b) yr effaith ar economïau a chymunedau lleol y mae rasio milgwn yn digwydd ynddynt ar hyn o bryd;
 - (c) y canlyniadau o ran lles anifeiliaid sy’n deillio o ddadleoli neu roi’r gorau i rasio milgwn rheoleiddiedig;
 - (d) y costau posibl i’r sector cyhoeddus sy’n deillio o orfodi, ailgartrefu, neu ymyriadau lles;
 - (e) unrhyw faterion eraill y nodwyd eu bod yn berthnasol yn adroddiad Pwyllgor Diwylliant, Cyfathrebu, y Gymraeg, Chwaraeon, a Chysylltiadau Rhyngwladol y Senedd ar rasio milgwn a osodwyd gerbron Senedd Cymru ar 5 Rhagfyr 2025.

’Human rights assessment

[] Assessment of human rights impact

- (1) The Welsh Ministers must undertake a human rights assessment of the impact this Act will have on persons affected by this Act.
- (2) The assessment must, in particular, consider –



- (a) the compatibility of prohibiting greyhound racing in Wales with Article 1 of the First Protocol to the European Convention on Human Rights (protection of property),
 - (b) whether such a prohibition pursues a legitimate aim in the public interest,
 - (c) whether the measures proposed are proportionate to that aim, and
 - (d) whether less intrusive alternatives could achieve the same objective.
- (3) The assessment must take account of the analysis and recommendations contained in the report of the Senedd’s Legislation, Justice and Constitution Committee on greyhound racing laid before Senedd Cymru on 5 December 2025.
- (4) The Welsh Ministers must –
- (a) publish, in such manner as they consider appropriate, a report of the assessment, and
 - (b) lay the report before Senedd Cymru.
- (5) The assessment must be completed and a report of the assessment laid before Senedd Cymru at least 3 months before the Welsh Ministers appoint a day under section 5(2).’.

 - (b) a yw gwaharddiad o’r fath yn anelu at nod dilys sydd o fudd i’r cyhoedd,
 - (c) a yw’r mesurau a gynigir yn gymesur â’r nod hwnnw, a
 - (d) a allai dewisiadau amgen llai ymwithiol gyflawni’r un amcan.
- (3) Rhaid i’r asesiad ystyried y dadansoddiad a’r argymhellion yn adroddiad Pwyllgor Deddfwriaeth, Cyfiawnder a’r Cyfansoddiad y Senedd ar rasio milgwn a osodwyd gerbron Senedd Cymru ar 5 Rhagfyr 2025.
- (4) Rhaid i Weinidogion Cymru –
 - (a) cyhoeddi, mewn unrhyw fodd y maent yn ystyried ei fod yn briodol, adroddiad ar yr asesiad, a
 - (b) gosod yr adroddiad gerbron Senedd Cymru.

- (b) publish, in such manner as they consider appropriate, a report on the review.

(2) The review must be completed before the end of the period of 3 years beginning with the day on which section 1 comes into force.’.
