Adolygiad o Arolygiaeth Gofal Iechyd Cymru

Cylch Gorchwyl

Y cefndir

Ym mis Gorffennaf 2013 cyhoeddodd y Pwyllgor Iechyd a Gofal Cymdeithasol ei fod wedi penderfynu cynnal ymchwiliad byr i waith Arolygiaeth Gofal Iechyd Cymru (AGIC). Cafodd yr adroddiad ei gyhoeddi ar 21 Mawrth 2014. Argymhellodd y Pwyllgor y dylai Llywodraeth Cymru gynnal adolygiad sylfaenol o AGIC, er mwyn diwygio, datblygu a gwella ei swyddogaethau rheoleiddio ac arolygu. Ddeng mlynedd ar ôl sefydlu AGIC - a'r Cynulliad Cenedlaethol bellach yn meddu ar gyfres o bwerau deddfu gwahanol iawn - cytunodd Llywodraeth Cymru mai dyma'r adeg iawn i gynnal adolygiad o'r fath. Yn ystod y degawd ers ei sefydlu mae AGIC, yn ddiamau, wedi cael cyfres o gyfrifoldebau ychwanegol. Bydd yr adolygiad yn ystyried a yw cylch gwaith AGIC bellach yn ddigon ystyrlon, gan ystyried sut y gellid ei symleiddio a'i gryfhau. Bydd yr adolygiad hefyd yn ystyried pwerau deddfu Gweinidogion Cymru sy'n cael eu harfer gan AGIC.

Diben

Bydd yr adolygiad annibynnol hwn felly'n ymdrin â'r meysydd canlynol:

- Adolygu swyddogaethau a chyfrifoldebau presennol AGIC. Bydd hyn yn cynnwys amlinellu hanes AGIC a disgrifio'r cyfrifoldebau ychwanegol a drosglwyddwyd iddi yn ystod y 10 mlynedd ers ei sefydlu, er mwyn pennu: a fyddai unrhyw rai ohonynt yn cael eu cyflawni'n well gan gorff arall; neu a oes unrhyw fylchau yn y gwasanaethau gofal iechyd y mae angen mynd i'r afael â nhw.
- Ystyried cylch gwaith AGIC o ran y GIG a'r sector gofal iechyd annibynnol, er mwyn pennu a oes digon o gydweithredu ar draws y sectorau sy'n sicrhau eu bod yn cydymffurfio â'r un safonau. Dylai hyn gynnwys yr elfen arolygu a'r elfen reoleiddio sy'n rhan o'i chylch gwaith.
- Elwa ar brofiadau arolygiaethau eraill, er enghraifft, y gwersi y gallai Cymru eu dysgu gan y methodolegau sy'n cael eu datblygu yn yr Alban, yng Ngogledd Iwerddon, ac yn Lloegr.
- Edrych ar batrwm cymhleth y ddeddfwriaeth sy'n sail i waith AGIC, a phenderfynu sut y gellid ei chydgrynhoi, ei symleiddio a/neu ei chryfhau, gan ystyried y newid sy'n digwydd ym maes gwasanaethau gofal iechyd a'r symud tuag at ddarparu mwy o ofal yn y gymuned.
- Rhoi ystyriaeth i waith ehangach, gan gynnwys yr Adolygiad Arolygu, Archwilio a Rheoleiddio, y Bil Rheoleiddio ac Arolygu, diwygio'r Cynghorau Iechyd Cymuned, a'r camau gweithredu perthnasol sy'n codi yn sgil Comisiwn Williams, er mwyn ystyried goblygiadau posibl y gwaith hwn mewn perthynas â gweithredu AGIC.
- Ymgymryd â chyfnod o feithrin perthynas â rhanddeiliaid allweddol er mwyn ceisio barn ehangach am ddyfodol swyddogaethau a chyfrifoldebau AGIC.

- Datblygu cynigion a fydd yn sail i ran o'r papur gwyrdd a fydd yn pennu cwmpas Bil ar gyfer Sicrhau Ansawdd yn y GIG, a gwneud argymhellion ar gyfer unrhyw gamau y gellid eu rhoi ar waith cyn i unrhyw newid deddfwriaethol ddigwydd.

Bydd yr adolygiad yn dechrau ym mis Gorffennaf 2014, a bydd adroddiad ar y canfyddiadau ar gael yn ystod yr hydref, 2014.

Review of Healthcare Inspectorate Wales

Terms of Reference

Background

In July 2013 the Health and Social Care Committee announced their decision to conduct a short inquiry into the work of Healthcare Inspectorate Wales (HIW). Their report was published on 21 March 2014. The Committee recommended the Welsh Government should undertake a fundamental review of HIW to reform, develop and improve its regulatory and inspection functions. The Welsh Government agreed that ten years after its creation - and now with a very different set of legislative powers available to this National Assembly - the time was right for such a review. In the decade of its operation HIW has, undoubtedly, acquired a series of additional responsibilities. The review will consider whether its remit is, now, sufficiently coherent and look for ways in which it may be able to be streamlined and certainly to be strengthened. The review will also consider the legislative powers of the Welsh Ministers which are exercised by HIW.

Purpose

This independent review will therefore address the following areas:

- To review HIW's existing functions and responsibilities. This will include plotting HIW's history and describing the additional responsibilities that it has acquired during its 10 year history, to determine: if any best sit elsewhere; or if there are any gaps across healthcare settings that need to be addressed.
- To consider the remit of HIW in respect of the NHS and the independent healthcare sector to determine if there is sufficient synergy across the sectors and application of common standards. This should cover both the inspection and regulatory arm of its remit.
- To draw on the experiences of inspectorates elsewhere, for example, identifying what lessons Wales can learn from methodologies being developed in Scotland, Northern Ireland and England.
- To look at the existing web of legislation underpinning HIW and form a view on where its needs to consolidated, simplified and/or strengthened, taking into account the changing provision of healthcare services and shift to more community based care.
- To take into account the wider related work, including the Audit, Inspection and Regulation Review, Regulation & Inspection Bill, Community Health Council reform and the relevant actions arising from the Williams Commission, in order to consider the potential implications of this for the operation of HIW.
- To undertake a period of engagement with key stakeholders to seek wider views on the future function and responsibilities of HIW

- To develop proposals to inform part of a green paper setting out the scope for an NHS Quality Bill and make recommendations for any immediate actions that could be put in place ahead of any legislative change.

The review will commence in July 2014 and will report its findings and proposals in the autumn of 2014.
