*Trust can be a barrier, sometimes this can be a long standing issues within a family for instance, and can take time to build.*

*Transport can be a barrier as NPT is geographically difficult to get around without a car. We do what we can as an organisation to ensure that our client group is reached.*

*Understanding what services are available can also be a minefield for our client group.*

o6. What barriers exist for services when trying to access support for client(s)?

*Funding is always an issues. Trying to break down barriers of trust within families to allow them to gain full access to services available.*

*Need to be targeting the 'Head Shops' that are popping up locally and selling so called 'legal highs' which are wreaking havoc in the communities and continuing to put our young people at high risk of accidental overdose and of accidents happening whilst under the influence of substances that they feel are 'safe' just because they are being sold freely.*

*We are battling with educating our client group about the dangers of these substances, but it is difficult when so many of the young people are using them and they are so easily available, not only locally but are so easy to purchase on the internet.*

*We also need to continue to address the issue of alcohol as we have with smoking, as it will take time to see changes.*
