My mother has lived in Rowen in the Conwy Valley for the last 50 years and as a non driver has relied on the buses heavily particularly after my father died as he was the driver.

The 19 bus used to travel through Rowen every 2 hrs both to Llanrwst and to Llandudno however, this is now limited to only a taxi service which takes passengers to Conwy only.

My mother used to attend a Luncheon Club in Conwy every week after her hospice day care finished and used Community Transport.

Community Transport ceased in Conwy almost 2 years ago and she now has no way of going to the Club and is missing all her old friends.

She has considered taking a taxi to Conwy but the price quoted of ${\tt f}$ 15 each way is prohibitive on a weekly basis.

She had also been using Community Transport for doctor and chiropody appointments for a nominal sum - this is no longer an option either.
