### Forward by Christine Chapman AM (Chair)

For some years in Wales there has been a growing concern about inequities within the justice system. One such inequity is the imprisonment of Welsh Women offenders and the effects their imprisonment has on their families.

While researching the issue of women prisoners the effects of imprisonment of either or both parents on children and families became overwhelming and compelling. A visit to HMP Parc witnessing the benefit of their innovative approach to family based interventions served as a further catalyst in seeking to improve the experiences of the children of prisoners and their families.

In order to both discover the effects of parental imprisonment on children and further define the issue a cross party group was established enlisting all party support. The intention of the group is to finish during the fourth assembly with a report seeking to make recommendations to Welsh Government in relation to both devolved and none devolved responsibilities.

We look forward to reporting on and debating the group findings in early 2016.

### National Assembly for Wales Cross Party Group on Children Affected by Parental Imprisonment (CAPI) – Terms of Reference (Subject to formal adoption)

#### **Vision**

The establishment of a National policy, legislative and practice framework ensuring that all children who experience the adversity of a parent in prison are recognised, are heard, and have an equal and fair chance to achieve positive outcomes in their lives.

#### **Terms of Reference**

There will be an expectation on those considered group members to contribute to the operation of the group, where ever reasonably possible, in person or by representative. Contributions made by a representative shall be considered as those of the group member unless otherwise specified.

There will be an expectation that whenever possible, group members or representatives will respond to information shared and requests made between scheduled meetings.

#### Discover - gather information, experiences and research

- Consider information gathered directly from families affected by imprisonment.
- Consider information gathered by specialist service providers.
- Consider information gathered from generic services for CAPI.
- Consider research findings.
- Consider new research priorities.
- Undertake service visits.
- Undertake other visits, e.g. HMP Parc.

#### **Define – describe and highlight the issues**

- Bring together the range of issues faced by families with CAPI illustrating the complexity of their needs and the adequacy of current responses.
- Consider the issues in relation to schedule 7.
  - Consider recommendations to Welsh Government
    - What could Welsh Government advocate for?
    - What could Welsh Government deliver?

#### **Disseminate**

- Take opportunities for written and oral questions in plenary.
- Take opportunities for short debates.
- Consider influence of future work plans and inquires of NAfW Committees.
- Produce Cross Party Group report including defining the issue and making recommendations to Welsh Government.

# May 13<sup>th</sup> Mid-Day Ty Hywel Inaugural meeting

This meeting will appoint members to key roles, explain rationale for the group, agree terms of reference and work plan, receive presentations from members to set the scene.

#### **Hidden Sentence**

This meeting will explore the "Hidden Sentence" served by the children and families of those imprisoned and will receive presentations from members to focus on some of the key issues

#### **Education**

This meeting will consider the role of education in identifying and supporting children and families affected by parental imprisonment and discuss the work that is already being undertaken in Wales to develop this area.

#### **Women prisoners**

To explore the particular issues that affect Welsh Women offenders who are imprisoned outside of Wales and the impact on their families.

#### Finance/Benefits

This meeting will focus on the financial impact of a parent/carer being imprisoned and how the loss of an income or benefit can mean vulnerable families are pushed further into poverty.

#### What next?

This meeting will focus on presenting the research that has been undertaken over the duration of the CPG and will seek to identify a strategy to progress recommendations.
