Petitions Committee Review of the National Assembly for Wales Petitions System

Summary of Outreach Work

Background

This document provides a summary of the Outreach work conducted as part of the Petitions Committee review into the Petitions system.

Methodology

As part of the review into the Petitions system the Outreach Team conducted a survey in both online and paper-based formats. Participants were asked a range of questions relating to what matters the Petitions committee should cover, who should be able to use the system and what action the Committee should take on petitions.

One survey was created with the aim of targeting the general public as a whole.

Awareness Raising

In order to promote awareness of the survey and attract participants the Outreach Team contacted a broad-range of organisations. Those contacted were able to raise awareness using a range of methods including — placing articles on websites; signposting on social media including Facebook and twitter; and emailing participants directly.

The surveys were also promoted by Assembly staff with relevant groups visiting the Senedd and receiving education visits, and during the Assembly's presence at summer shows.





- Yes: 51.07% (167)






Question three - The Assembly does accept petitions about other public bodies in Wales (e.g. Local Health Boards and the decisions they make about local health services). Should this change?




Question four - Have you ever submitted a petition to the Assembly?




Question five - Have you ever signed a petition to the Assembly?

Question six - Ten signatures are needed for a petition to be considered by the Assembly's Petitions Committee – is this too many, too few or about right?






Question seven - Petitions submitted by an organisation, or by an association or group, do not require a minimum number of signatures. Should this continue?






Question nine - Should only people who live in Wales be allowed to submit a petition?


Question 10 - Should only people who live in Wales be allowed to sign a petition?


Question 11 - Should there be a minimum age to submit a petition? What do you think the minimum age should be?








Question 13 - Should political parties be allowed to submit petitions?




Question 14 - Should the Assembly's Petitions Committee be able to refer petitions to the Ombudsman, where they believe there are grounds for him/her to investigate?








Question 18 – What is your gender?


Question 19 – Are you a disabled person, or a person with a learning difficulty?

- Yes: **4.14% (13)**


