## **Consultation questions**

**Question 1** – What are your views on whether there is a prevalence in the use of supply teachers on a planned and unplanned basis?

I am not aware that there is a prevalence in the use of supply teachers at my school. Numbers vary from year to year.

If you believe that this results in problems (for example, for schools, pupils or teachers), how do you think they could be resolved?

Recognising that a supply teacher will rarely be able to do as good a job as the class teacher we must accept that the children`s education will suffer. Every effort should be made to minimise the absence of classroom teachers. Where supply teachers are required they should be subject specialists and it would be an beneficial if they were familiar with the school. They need proper support. It is essential that they are fully qualified teachers.
