### SL(5)003 -The European Maritime and Fisheries Fund (Grants) (Wales) Regulations 2016

Procedure: Negative

These Regulations put in place a mechanism to allow the Welsh Ministers to co-finance assistance provided to the fisheries and aquaculture sector from the new European Maritime and Fisheries Fund, as they apply to the operational programmes established under Regulation (EU) No 508/2014.

In addition, these Regulations revoke and replace the European Fisheries Fund (Grants) (Wales) Regulations 2009 (SI/2009/360) ('the 2009 Regulations'). They contain a transitional provision so that applications received by the Welsh Ministers before 31 December 2015 will continue to be dealt with under the terms of the 2009 Regulations.

# SL(5)005 - The Waste (Meaning of Recovery) (Miscellaneous Amendments) (Wales) Regulations 2016

The amendments made by these Regulations are necessary in order to implement Commission Directive (EU) 2015/1127 of 10 July 2015 amending Annex II to the Waste Framework Directive (OJ No L 184, 11.7.2015, p. 13).

## SL(5)006 – The Marine Licensing (Exempted Activities) (Wales) (Amendment) Order 2016

This Order amends the Marine Licensing (Exempted Activities) (Wales) Order 2011 ("the 2011 Order"), which contains a reference to Directive 2008/98/EC of the European Parliament and of the Council of 19 November 2008 on waste and repealing certain Directives (OJ L 312, 22.11.2008, p. 3.) ("the Waste Framework Directive").

The amendment made by article 2 of this Order is necessary in order to implement amendments to the Waste Framework Directive made by Commission Directive (EU) 2015/1127 of 10 July 2015 amending Annex II to the Waste Framework Directive.

Article 2 of this Order amends the reference to the Waste Framework Directive in the 2011 Order.
