Follow-up to evidence on 18 January 2017

Thank you for your further letter of 7 March requesting additional information on a number of areas following our attendance at the Children, Young People and Education Committee on 18 January 2017.

Child and Adolescent Mental Health Services (CAMHS)

In relation to the request set out in your letter; we wrote to you on 2 February 2017 regarding the 28-day target. Our letter confirmed we do collect and publish waiting time data against the target which addresses the information you are seeking, and have done this since 2010.
